THIS REQUEST IS FOR A PERMISSION TO ENCROACH ONTO SIX FEET OF A UTILITY EASEMENT FOR A POOL AND DECK IN LOT 21, BLOCK 2, COBBLESTONE WEST ADDITION, SECTION II. THE POOL AND DECK TO BE LOCATED ON THE WEST SIDE OF PROPERTY AT $4700\ 12^{\text{TH}}$ AVENUE S.E., NORMAN OK 73072
