## Request for retaining wall installation:

Meek's Landscaping & Irrigation, LLC, on behalf of the homeowners Holly and Robert Hagen at 621 Summit Crest, Norman, Ok. respectfully request permission to construct a small retaining wall within the utility easement. The wall will be constructed with 'Trinity Block' pre-engineered block and will run approximately 90' from the south end of the property to the N. E. corner of the house. The wall will be 14" off the east property fence. The wall will be 3' tall at the south end and gradually step down to 1' tall at the north end. Backfill will extend to 8' west of wall gradually decreasing towards the west. No more than 6" to 1' of soil will be applied over existing utilities. The City of Norman has given us permission to do the work in respect of their storm sewer line. We would greatly appreciate a response in a timely manner in order to solve the erosion problem for the homeowner property and adjoining properties.
