ITEM: Consideration of SHORT FORM PLAT NO. SFP-1819-1 FOR HOLLYWOOD BANK ADDITION, A PART OF BLOCK A, HOLLYWOOD ADDITION.

LOCATION: Located at 1600 West Lindsey Street (900 feet east of McGee Drive on the south side of West Lindsey Street).

HISTORY:

- 1. <u>September 8, 1959</u>. City Council adopted Ordinance No. 1171 annexing this property into the Corporate City Limits and placing it in R-1, Single-Family Dwelling District.
- 2. November 17, 1959. Planning Commission recommended to City Council placing this property in the C-2, General Commercial District and removing it from R-1, Single-Family Dwelling District.
- 3. November 17, 1959. Planning Commission recommended that the final plat for Hollywood Addition be approved.
- 4. November 24, 1959. City Council approved the final plat for Hollywood Addition.
- 5. November 30, 1959. The final plat for Hollywood Addition was filed of record with the Cleveland County Clerk.
- 6. <u>December 22, 1959</u>. City Council adopted Ordinance No. 1190 placing this property in the C-2, General Commercial District and removing it from R-1, Single-Family Dwelling District.
