Any revisions to this quote are subject to Customer's approval upon notification whether in person or by telephone. All price quotes are exclusive of any taxes or chemicals and hazardous disposal fees.

Customer has authorized all repairs set forth herein and releases dealership from liability for delay in the repair of the vehicle and for damage to the vehicle or loss of Customer's personal property in the vehicle. Customer has authorized Dealership's employees to operate the above vehicle on streets, highways, or elsewhere for the purpose of testing and/or inspecting the vehicle.
