Parcel 10 - Temporary Construction Easement

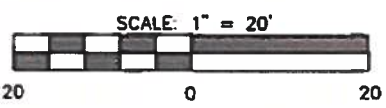
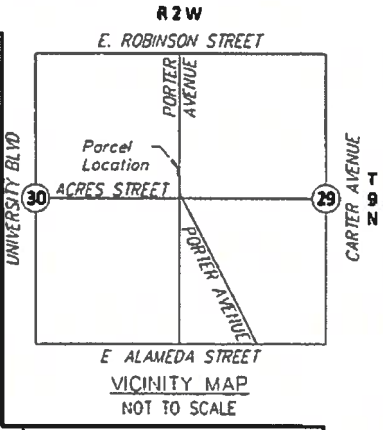
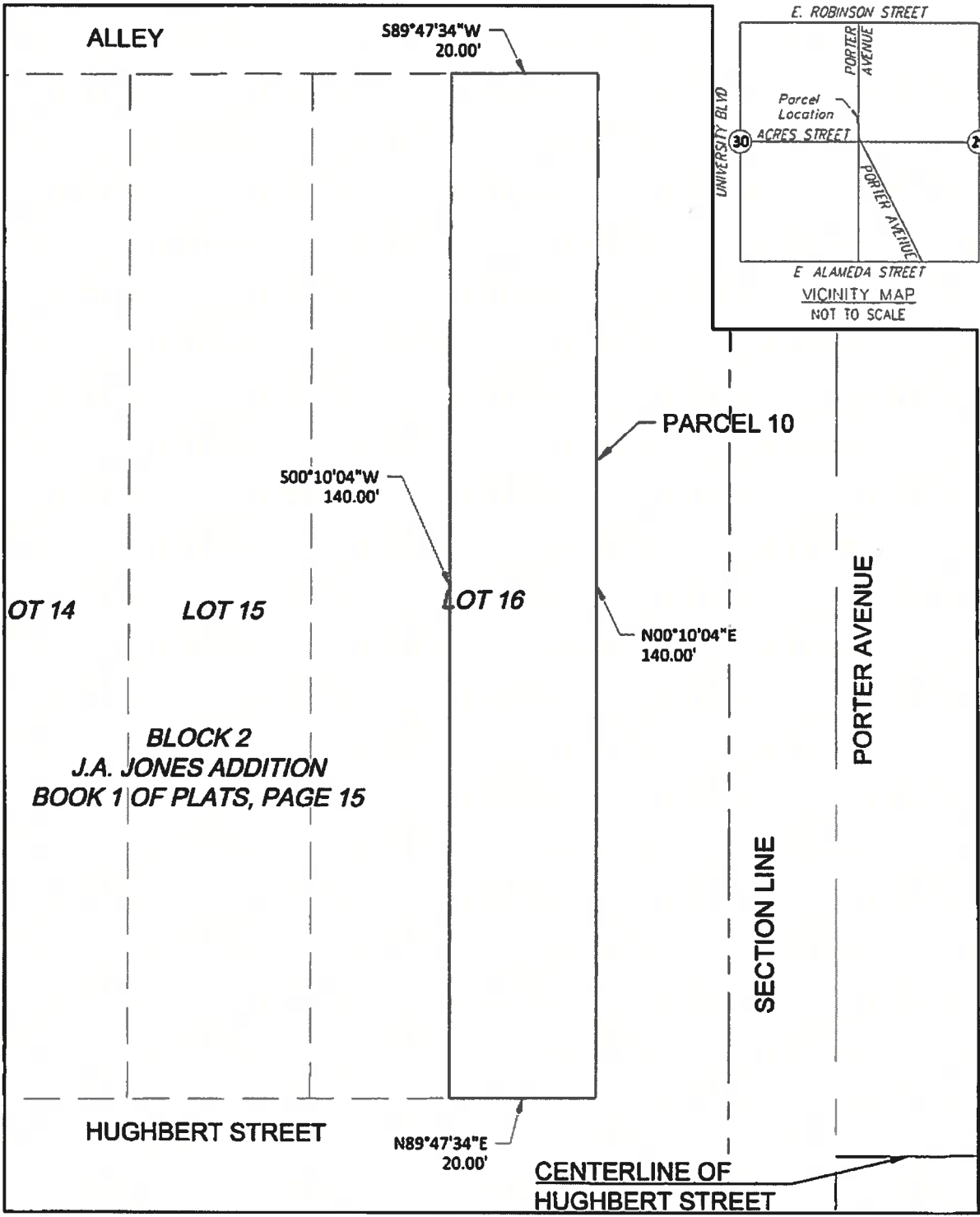
