GRANT OF EASEMENT

Know all men by these presents:

That **Ivan Teel and Dorothy Teel, husband and wife**, for and in consideration of the sum of One Dollar (\$1.00), receipt of which is hereby acknowledged, and for and upon other good and valuable considerations, do hereby grant, bargain, sell and convey unto the City of Norman, a municipal corporation, a public utility easement and right-of-way over, across, and under the following described real estate and premises situated in the City of Norman, Cleveland County, Oklahoma, the following described land to wit:

A strip of land located in the Northwest Quarter of Section 23, Township 9 North, Range 1 West, Cleveland County, Oklahoma, being a part of Tract #11, Round Tree, and being more particularly described as follows:

Beginning at a point on the present South right-of-way line of Rock Creek Road a distance of 828.30 feet North 89°44'15" East of and 33.00 feet South 00°19'49" East of the Northwest corner of said Section 23; thence North 89°44'15" East along said right-of-way line a distance of 256.94 feet; thence South 00°19'49" East a distance of 24.24 feet; thence South 88°48'00" West a distance of 256.97 feet; thence North 00°19'49" West a distance of 28.45 feet to the Point of Beginning.

Containing 6,770 square feet, more or less of new right-of-way.

With the right of ingress and egress to and from the same, for the purpose of surveying, laying out, constructing, maintaining, and operating a public roadway, drainage structure or utility.
