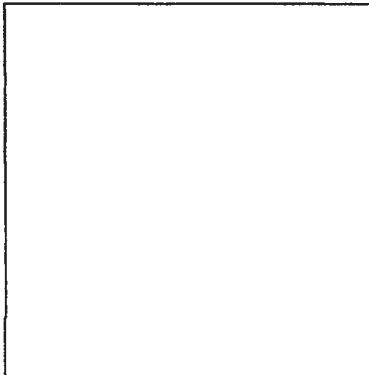


**PROFESSIONAL LAND SURVEYOR'S

KNOW ALL MEN BY THESE PRESENTS THAT

1. I, Robert C. Outland, a Licensed Professional Land Surveyor, hereby certify that I am the Land Surveyor that executed and sealed the subdivision plat of THE MILLENNIUM ADDITION, being a part of the NE/4 OF SECTION 5, T8N, R2W, OF THE I.M., CITY OF NORMAN, CLEVELAND COUNTY, OKLAHOMA, which was duly approved and accepted by the City Council of the City of Norman on September 23, 2014 and subsequently filed and recorded in the office of the Cleveland County Clerk in Plat Book 24 at Page 46, on the 7th day of May, 2015.

2. I further certify that it has come to my attention that the paragraph labeled as "NOTE" located in the lower left-hand quadrant on the first page of the plat contains a scrivener's error that needs to be corrected in order to recite the actual intent and fact of the meaning of the "NOTE".
The "NOTE" as it appears on the recorded plat reads as: NOTE: All easements created by, and any building lines shown on, the Plat of UNIVERSITY PLAZA ADDITION recorded in Book 17, Page 198, and the Plat of BOYD VIEW No. 1 recorded in Book 5, Page 76, are vacated by this Final Plat of THE MILLENNIUM ADDITION.

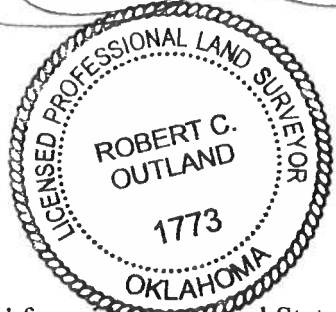
3. I further certify that the referenced "NOTE" should have read and is hereby corrected to read as follows:

NOTE: All easements created by, and any building lines shown on, the Plat of UNIVERSITY PLAZA ADDITION, recorded in Book 17, Page 198, and the Plat of BOYD VIEW ADDITON No. 2, recorded in Book 7, Page 96, that lie within the boundary of this Final Plat of THE MILLENNIUM ADDITION, are hereby vacated pursuant to the approval and acceptance of this Plat by the City of Norman and the subsequent recording of this Plat in the records of the Cleveland County Clerk.

The correction of the scrivener's error stated above is hereby amended and corrected by this Certificate pursuant to the provisions of Title 11 Section 41-115 of the Oklahoma Statutes.
