A RESOLUTION OF THE COUNCIL OF THE CITY OF NORMAN, OKLAHOMA, ACCEPTING FUNDING IN THE AMOUNT OF \$737,568 FROM THE CORONAVIRUS AID, RELIEF, AND ECONOMIC SECURITY (CARES) ACT TO BE USED BY THE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM, CREATING A FUND TO DEPOSIT FUNDING, AND APPROPRIATING THE FUNDING INTO VARIOUS ACCOUNTS TO PROVIDE RENTAL ASSISTANCE AND OPERATE A STREET OUTREACH PROGRAM FOR PERSONS EXPERIENCING HOMELESSNESS.

- § 1. WHEREAS, the CARES Act was approved to assist households in Norman in addressing the current financial impact associated with the COVID-19 crisis to be distributed utilizing the existing ESG formula to all Entitlement Communities and States; and
- § 2. WHEREAS, the City of Norman has received an additional \$737,568 which will be used to fund a rent assistance program and operate a street outreach program for persons who are experiencing homelessness; and
- § 3. WHEREAS, a revenue account has been established and funding has been deposited into that account to allow appropriation of these funds to the necessary accounts; and
