#### MISCELLANEOUS DISCUSSION

Oil and Gas Inspections. Mr. Mike Rainer, 4705 Augusta Drive, provided a packet of information to Council. He said his packet included the current well site inspection form that did not exist three years ago but had been brought about by the City Council Oversight Committee after discovering there was no written documentation provided with the oil and gas inspections. In his opinion, the current inspection form is incomplete and there are no inspections being done on tank batteries that he is aware of. He created an inspection form that would, in his opinion, be a complete oil and gas inspection form. He said it is much more comprehensive and incorporates more of the things that are within Section 13 of the Oil and Gas Code. He said it also allows incorporated from the Oklahoma Corporation Commission. He said the database will populate for each well. He said anyone interested in a particular well can go into the database and look at all information regarding that particular well. He said, in his opinion, the current oil and gas inspector is not qualified to do his job because he had no professional training or no special licenses to perform his job. He said he would be glad to show his form to City staff.

Ms. Cindy Rogers, 633 Reed Avenue, thanked Mr. Rainer for his efforts and encouraged Council to look at his work.
