

Amendment No. 1 to Contract No. K-1516-43

THIS AMENDMENT NO. 1 TO CONTRACT NO. K-1516-43 made and entered into this ____ day of _____, 2015, by and between the Norman Utilities Authority, a public trust of the State of Oklahoma, hereinafter designated as the AUTHORITY, the City of Norman, Oklahoma, a municipal corporation of the State of Oklahoma, hereinafter designated as the CITY, and McKee Utility Contractors, Inc., hereinafter designated as the CONTRACTOR.

WITNESSETH:

WHEREAS, the AUTHORITY and the CONTRACTOR entered into Contract No. K-1516-43 on September 22, 2015 for the completion of Phase 2 of the Berry Road Waterline Project; and

WHEREAS, the CITY desires to coordinate certain road improvements in the same area impacted by the NUA'S Berry Road Waterline Project and significant cost savings can be achieved through project coordination; and

WHEREAS, the CONTRACTOR has agreed to extend the unit prices bid for the Berry Road Waterline Project and complete the related street improvements.

NOW THEREFORE, for and in consideration of the mutual agreements, and covenants contained herein and in the original agreement, the parties to this CONTRACT have agreed, and hereby agree as follows:

- 1) The CONTRACTOR agrees to perform the additional work outlined in Attachment A hereto at the unit prices incorporated into Contract No. K-1516-43 and made applicable hereto as if fully set forth herein.
- 2) The CONTRACTOR shall, in a good and first-class, workman-like manner at his own cost and expense, furnish all labor, materials, tools, and equipment required to perform and complete said work in strict accordance with this CONTRACT.
- 3) All other terms of the contract shall remain in full force.
