Amendment No. 1 to Contract No. K-1516-43

THIS AMENDMENT NO. 1 TO CONTRACT NO. - 2) The CONTRACTOR shall, in a good and first-class, workman-like manner at his own cost and expense, furnish all labor, materials, tools, and equipment required to perform and complete said work in strict accordance with this CONTRACT.
- 3) All other terms of the contract shall remain in full force.
