Parcel No. 12 Legacy Trail Multimodal Path

GRANT OF RIGHT-OF-WAY City of Norman

Know all men by these presents:

That Oklahoma Gas and Electric Company – ("OG&E"), for and in consideration of the sum of One Dollar (\$1.00), receipt of which is hereby acknowledged, and for and upon other good and valuable considerations, do/does hereby grant, bargain, sell, and convey unto the City of Norman, a municipal corporation, a Sidewalk Easement and right-of-way over, across, and under the following described real estate and premises situated in the City of Norman, Cleveland, Oklahoma, to wit;

A strip, piece or parcel of land lying in the Northwest Quarter (NW/4) of Section Fourteen (14), Township Nine (9) North, Range Three (3) West of the Indian Meridian, Cleveland County, Oklahoma. Said parcel of land being described by metes and bounds as follows (and depicted in attached Exhibit B-Parcel 12):

Commencing at the Southwest Corner of the Southwest Quarter (SW/4) of Section 14; Thence North 00°28'36.05" West along the West Section Line of Said Section, a distance of 2,640.90 feet; Continuing North 00°27'55.57" West along the West Section Line of said Section, a distance of 350.00 feet; Thence North 89°13'44.43" East a distance of 50.00 feet to a point on the Existing Right-of-Way, the same point being the Point of Beginning;

Thence North 89°13'44.43" East a distance of 10.00 feet; Thence North 00°27'55.57" West a distance of 65.00 feet; Thence South 89°13'44.43" West a distance of 10.00 feet;

Thence South 00°27'55.57" East a distance of 65.00 feet to the Point of Beginning.

Said parcel containing 649.95 square feet, or 0.01 acres more or less, of New Right-of-Way for <u>sidewalk</u> improvements.

All bearings contained in this description are based on the Oklahoma State Plane Coordinate System and are not astronomical bearings.

The City of Norman acknowledges and agrees that in the event that sidewalks are damaged during the City of Norman's construction, operation or maintenance of its facilities the City of Norman shall be solely responsible for the repair or replacement of such damaged sidewalks and other property of OG&E, including without limitation, replacement of all signage removed or destroyed during the operations of the City of Norman, and related to this Sidewalk Easement.

Further, to the extent allowed by applicable law, the City of Norman remises, releases and forever discharges Oklahoma Gas and Electric Company and its affiliates, directors, officers, employees, agents, successors and assigns (collectively and individually "OG&E"), of and from any and all debts, demands, actions, causes of action, suits, proceedings, agreements, contracts, judgments, damages accounts, executions, claims and liabilities whatsoever of every name and nature, whether known or unknown, whether or not well founded in fact or in law or in equity or otherwise, which relate to damages to property or injuries to persons as a result of the relocation of the new multi-modal path.

The City of Norman further agrees that it shall not change grade such that water does not encroach upon OG&E's property adjacent to the Sidewalk Easement herein granted.

The City of Norman further agrees that if the Sidewalk Easement granted herein is ever abandoned this Sidewalk Easement shall become null and void, and the property shall revert back to OG&E.
