A strip, piece or parcel of land lying in the Southwest Quarter (SW/4) of Section Fourteen (14), Township Nine (9) North, Range Three (3) West of the Indian Meridian, Cleveland County, Oklahoma. Said parcel of land being described by metes and bounds as follows:

*Commencing at the Southwest Corner of the Southwest Quarter (SW/4) of Section 14;
Thence North 00°28'36.05" West along the West Section Line of Said Section, a distance of 511.83 feet;
Thence North 89°05'18.95" East a distance of 50.00 feet to a point on the Existing Right-of-Way, the same point being the Point of Beginning;
Thence North 89°05'18.95" East a distance of 10.00 feet;
Thence South 14°44'45.60" East a distance of 25.76 feet;
Thence South 89°05'18.95" West a distance of 10.00 feet;

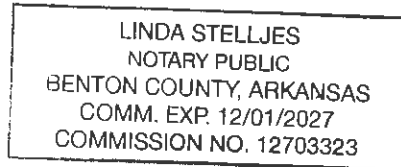
