RE: CDBG DR Round #12 - City of Norman Request

DR-2014-NORMAN-CI-00064; Contract 16237 CDBG DR 13

Dear Mr. Hoover,

The City of Norman is requesting a total of \$719,970 of funding (Infrastructure) to be submitted in coordination with Oklahoma Department of Commerce Disaster Funding Request Round #12. These funds are for the construction costs to be incurred for the two remaining projects that were approved under application DR-2014-NORMAN-CI-00064. Previously awarded funding (Round Three; 16237 CDBG DR 13; \$721,312) designated for all seven projects allowed for survey, design, environmental, etc. in preparation for the bidding of the projects. Additional funding was awarded for five of the seven projects (Round Nine; 16604 CDBG DR 13; \$10,602,808) that included the expenditures for construction, construction management, etc.

These seven projects were aligned into three work groups determined by their proximity in location to each other and be bid as individual projects but awarded as the lowest and best bid total of each group. A subsequent award of two projects, 16570 CDBG DR 13 was designated as Group Four.

The environmental process was included in the previous funding and is complete for all seven projects included in the DR-2014-NORMAN-CI-00064 application.

Below is our current assessment of the CDBG-DR projects that have been awarded to the City of Norman and the projected timeframes for the expenditures of funds.

16237 CDBG DR 13; APPLICATION DR-2014-NORMAN-CI-00064; Groups One-Three

- 1. The Round Three award (12/15/2014) was in the amount of \$731,312 and included \$690,400 for design, \$20,000 for right-of-way acquisition, and \$21,312 in administration funds. The City of Norman executed the Contract with ODOC accepting the award on 2/24/2015 (K-1415-108).
- 2. On May 16, 2015, the City of Norman distributed a Request for Proposal (RFP-1415-29) to solicit design services for the seven project locations. Twenty-One proposals were received and reviewed, and after interviewing the four highest ranked firms, Atkins of North America of Norman, OK. Was selected.
- 1. On August 25, 2015 The City of Norman executed a contract (K-1516-44) in the amount of \$690,400 with Atkins of North America for the design of the seven projects. Design work including environmental clearance and construction plans/specifications for these projects are complete.

- 2. On December 15, 2016 Contract 16237 was closed out with recaptured balances that included \$1,741.76 of Administration and \$20,000 of Infrastructure funds. Recaptured Infrastructure funds were designated for Right-of-Way acquisition that did not occur under this contract.
- 3. The Round Nine Award 16604 CDBG DR 13 (04/12/2016) was in the amount of \$10,602,808 and included funds for construction, construction management, testing, etc. for five of the seven locations (Groups One and Two) that were awarded. As a result of this award, Amendment Number 1 to K-1516-44 (04/12/2016) with Atkins North America was amended to include the construction management, testing, etc. that will be associated with the projects at these five locations. The two year window for completion of these two groups of projects ends March 11, 2018.
- 4. As described, the seven approved projects were grouped for project phasing and are in the following stages:

Group One

Project 3 84th Ave NE-from Tecumseh Road to Franklin Road (3 miles)

Project 5 Tecumseh Road-from 84th Ave NE to 120th Ave NE (3 miles)

Project 6 96th Ave NE-from Tecumseh Road to Arrowhead Drive (1+ miles)

16570 CDBG DR 13; APPLICATION DR-2014-NORMAN-CI-00102; Group Four

- 1. The Round Seven award was in the amount of \$5,004,821 for two locations (Group Four). The City of Norman executed the Contract with ODOC accepting the award on 2/09/2016 (K-1516-107). In conjunction with this award, Amendment Number 1 to Contract K-1516-44 was executed with Atkins North America for design, construction management, testing, etc. for these two projects.
- 2. The two-year window for project completion ends December 11, 2017.
- 3. The two approved projects were grouped for project phasing and are in the described stages:

Group Four

Project 8 120th Ave NE-from Tecumseh Road to Stella Road (4 miles)
Project 9 Stella Road from 132nd Ave NE to 144th Ave NE (1 mile)
