Dear Mr. Madenwald,

On Thursday, June 11, 2020, six bids from general contractors were received, opened, and publicly read at the Authority's office in Norman, Oklahoma for the above-referenced project. The base and alternate bids were as follows:

It is our opinion that the Base Bid plus Alternate No. 2 will have less impact on the Authority's customers and should be selected over the Base Bid plus Alternate No. 1. Our final Opinion of Probable Construction Cost (OPCC) for the Base Bid Plus Alternate No. 2 was \$ 2,980,405.00. The low Base Bid Plus Alternate No. 2 of \$1,978,875.00 was submitted by Garney Companies, Inc. PLUMMER did not identify any math errors in the base and alternate bids for Garney Companies, Inc bids. There were math errors with 4M Trenching, LLC, Mathews Trenching Co., Inc, and Marsau Enterprises Inc., but the errors did not change the outcome of the bid.

Garney Companies, Inc. has extensive pipeline construction experience in Oklahoma and throughout the Nation. PLUMMER contacted references provided by Garney Companies, Inc. and received positive feedback. Garney Companies, Inc. proposal appears to be in order, and the proposal meets the requirements of the specifications. Therefore, PLUMMER recommends that the contract for the Base Bid Plus Alternate No. 2 for construction of Project WA0242I; Robinson Street Waterline Replacement, Phase III be awarded to Garney Companies, Inc., in the amount of \$ 1,978,875.00
