#### PRESENTATION BY STAFF:

- 1. Janay Greenlee reviewed the staff report, copies of which are filed with the minutes. Staff supports this request and recommends approval of Ordinance No. O-1920-19.
- 2. Mr. Lewis Ms. Greenlee, I'll ask the same question. Is there any ventilation in process, because to the north of that is R-1 and, again, residents certainly don't want to smell there's complaints all over the country in regards to odor control.
- Ms. Greenlee I do believe this area is contained inside it's a suite inside the building. What she's going to be doing is getting packaged medical marijuana from a grower, taking it into there and then using a grinder to grind it up and putting it in a rolling machine. So as far as any odor containing ventilation in that little small suite, it just is going to be your normal ventilation as far as what's already on-site there.
- 3. Mr. Boeck The space closest to the alley, close to the housing, is Yellow Dog Coffee. And then Brent Swift's office, and then her space would be the one closest to Tonhawa.
- 4. Mr. Lewis And there's no extraction?Ms. Greenlee No extraction on-site.

Ms. Greenlee – You can look on the OMMA website and they will show you all the licenses for growers. They don't give the location for growers because of security reasons. But for processors, dispensaries, researchers – every city, every town – there's a list of all of the licensed growers, dispensaries, and researchers.

Ms. Hudson – Also, the City Clerk's office is issuing those licenses with the City of Norman, so while you can look at the OMMA website, you'll see what the State is issuing, but we can check with the City Clerk's office and we can send that out to you if you want.

Mr. Jan - Yes, that would be nice. Thank you so much, Jane.

Dave Boeck moved to recommend approval of Ordinance No. O-1920-19 to the City Council. Tom Knotts seconded the motion.
