# MISCELLANEOUS DISCUSSION

Quality of Life Initiative. Mr. Roger Gallagher, 1522 East Boyd Street, voiced concerns about the scheduled times for upcoming meetings of a citizens' initiative quality of life proposal because they are daytime meetings and sometimes it is not convenient for those who work. He suggested the time be changed to 6:30 p.m. or 7:00 p.m.

Councilmember Castleberry said there will be multiple meetings scheduled at all times of day to address everyone's needs. He said the dialogue on the initiative, Norman Forward, is very important and this will allow everyone a chance to attend.

Mr. Steve Lewis, City Manager, said he had been in contact with representatives of this initiative and they are working together to bring a presentation to City Council, hopefully in August, to update the Council and the community.

Housing and Urban Development (HUD). Mr. Roger Gallagher, 1522 East Boyd Street, said there are approximately 1,200 cities in the United States that have accepted HUD funding including the City of Norman and because HUD guidelines must be followed, sometimes the housing of illegal residents is required. He asked if the City of Norman is locked in to taking these illegal residents for a temporary or extended stay.

\*

Rezoning for Large Projects. Ms. Diane Hardersen, 2704 Dunham Drive, said she recently wrote a letter to The Norman Transcript expressing her dismay at the loss of green space from the project going in where the former Sooner Mobile Home Park used to be. She said she was here tonight because Council was considering rezoning property for a third Wal-Mart Super Center. She felt the public should be made more aware when these types of zoning projects come forward.

Mr. Mike Rainier, 4705 Augusta Drive, said a project the size of a Wal-Mart will impact an area greater than 350 feet and suggested that the Homeowner's Association (HOA) or agent for that HOA be notified to notify the residents of the addition that is affected.

Councilmember Heiple said Council had some tough decisions to make and it was important to create a healthy balance between the money that comes in to this community to allow City services to continue and at the same time not allow development to get out of control.

Miscellaneous Discussion, continued:

Rezoning for Large Projects, continued. Councilmember Castleberry said he was disturbed about the lack of disclosure although he understood the reason, and his hope with this postponement is that the applicant will present a Planned Unit Development (PUD) to allow Council and the citizens to know more about the project. He said more details will allow Council to make good decisions. He said the applicant needs to get a fair hearing regardless of who they are and if Council does not decide to approve this, it has to be for a good reason.

Councilmember Jungman said the postponement this evening was strategic, but there are real reasons to say no. He said other communities have precluded stores of this type because they cause social problems. He said the opening of this Wal-Mart will likely close one or two grocery stores in town. He said it worked on the west side, but the east side does not have the intensity of commerce. He said Council needs to make a decision that reflects the value for the whole community and not just the convenience of one developer.

Mayor Pro Tem Chad Williams expressed similar concerns about the rezoning regarding Wal-Mart. He looks forward to seeing what the applicant will be bringing back to Council on August 12th. He hoped some of the concerns brought up this evening will be addressed and believed Staff will work to get some of the answers.

<u>Thanks to Police Department</u>. Ms. Ann Gallagher, 1522 East Boyd Street, commended the Police Department for their quick response to a recent incident in her neighborhood.

Striping Projects. Councilmember Greg Heiple thanked the Public Works Department for striping 36th Avenue East from Alameda to Lindsey Street. He said the intersections had been cleaned out and the new yellow line increased safety for the residents of Highland Hills and Summit Lakes.

Councilmember Miller said the Oklahoma Department of Transportation is currently striping Highway 9 east all the way to Clear Bay and a citizen saw that the project was being done incorrectly and contacted the Public Works Department and it has been totally restriped. She thanked them for bringing it to the City's attention.

Councilmember Holman said he wished all section line roads could be striped because at night the roads are really dark and the terrain is treacherous.

<u>Animal Welfare Issues</u>. Councilmember Robert Castleberry said Council had received numerous emails regarding the Animal Welfare Center and their policies and he asked Councilmember Miller if this could be something that the Oversight Committee could put on their agenda.

Council member Holman said there are several people who have expressed concerns about these issues and Council is still receiving information about these problems. He said Council will come up with the best possible solution to address the issues. He knows these issues are time-sensitive and asked for patience.

<u>Highway Nine Construction</u>. Councilmember Holman said Highway 9 has been a dangerous road for a long time and urged everyone to drive carefully during the construction project.

Household Hazardous Waste Event. Mr. Steve Lewis, City Manager, announced that the Household Hazardous Waste Event would be held Saturday, November 1st from 9:00 a.m. to 2:00 p.m. at the Lloyd Noble Center.

The Passing of James Garner. Mayor Pro Tem Chad Williams recognized the passing of James Garner who has a lot of family in this community. He said Mr. Garner had brought a lot of recognition to the City of Norman and had made a huge impact. He wanted Mr. Garner's family to know that Council stands behind them and supports them during this time and are praying for strength and peace.
