A RESOLUTION OF THE COUNCIL OF THE CITY OF NORMAN, OKLAHOMA, AUTHORIZING FOOD FOR **THOUGH LEARNING** INSTITUTE PROJECT AGENT, UNDER THE SOCIAL AND VOLUNTARY SERVICES **COMMISSION** CONTRACT IN THE **AMOUNT** \$4,700 APPROVED TO BE USED SPECIFICALLY TO **PURCHASE SUPPLIES** TO **FURTHER** PARTNERSHIP WITH BABY STEPS OF NORMAN, CENTER FOR CHILDREN AND **FAMILIES** SUMMER ENRICHMENT PROGRAM, DIMENSIONS ACADEMY, BRIDGES, AND THE PLANET REAVES PROGRAMS.

- § 1. WHEREAS, the City of Norman, Oklahoma, does hereby acknowledge that the tax-exempt status of this political subdivision is a significant factor in determining the agreed contract for \$4,700 with Food for Thought Learning Institute, through the FYE 2015 Social and Voluntary Services Commission funding allocation; and
- § 2. WHEREAS, the City of Norman, Oklahoma, in compliance with State law, desires to confer Food for Thought Learning Institute, its special State and Federal sales tax exemptions and in order to achieve such end, finds it necessary to appoint as its direct purchasing agent, the Food for Thought Learning Institute to purchase materials which are, in fact, incorporated in, and used specifically to purchase supplies to further the partnership with Baby Steps of Norman, Center for Children and Families Summer Enrichment Program, Dimensions Academy, Bridges, and the Planet Reaves Programs; and
- § 3. WHEREAS, this limited agent status is conferred with the express understanding, Food for Thought Learning Institute shall appoint employees and subcontractors as subagents who shall be authorized to make purchases on their behalf.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NORMAN, OKLAHOMA:

§ 4. That the City of Norman, Oklahoma, on the 28th day of October, 2014, did authorize the Food for Thought Learning Institute under the Social and Voluntary Services Commission contract in the amount of \$4,700, an agent of the City of Norman, Oklahoma, solely for the purpose of purchasing, on a tax-exempt basis, supplies to further the partnership with Baby Steps of Norman, Center for Children and Families Summer Enrichment Program, Dimensions Academy, Bridges, and the Planet Reaves Programs.
