Policy for Body Cameras. Ms. Ann Gallagher, 2513 Woodsong Drive, said information had been provided on the website and Council had received the policy via email. She said there was a public meeting about the body camera policy which she had attended as well as a study session. She felt all questions asked by the public were answered adequately with intelligence and compassion. She said as far as having an Oversight Committee to look at the video, there are legal issues on who should see the video; those people would have to be vetted and know what the law is. She said Council should use kind words and there were too many disrespectful words used tonight. She said Body Cameras are so important because although people are able to see videos done by the media and on people's phones, what is on a Body Camera is right in front of the police officer. She said she trusts the Police Department and this City's policies used by the Police Department to help our citizens. She said Council should remember that they are elected officials and although the pay is not great, it is Council's responsibility to do their homework. She said if a Councilmember is not spending a minimum of 30 hours a week reading their material, then maybe they are not doing their job. She said staff is always very open and Council and all citizens have access to them.

Miscellaneous Discussion, continued:

<u>Policy for Body Cameras, continued</u>. Mr. Steve Ellis, 633 Reed Avenue, said he was surprised there is no public oversight into the Norman Police Department policies.

Ms. Cindy Rogers, 633 Reed Avenue, thanked City Council for their service and commitment and said oversight does not have to be a bad thing. She said she wanted to make it clear that Chief Humphrey had been perfectly transparent; she just has a problem with the process. She said oversight could occur by a trained professional that might not be a resident of the City.

Mr. Tom Turner, 1308 Luke Lane, said he is an advocate of Body Cameras. He said he drove a school bus for ten years and when cameras were placed on the school buses, everybody hated them but in his case, they save him three times in ten years.

Councilmember Allison said he had been embarrassed this evening during discussion about this item and had received texts from citizens who had left the meeting because they were embarrassed. He said he hoped he never had to experience this again and it had not been a good night for him to be proud of being a City of Norman City Councilman.

Councilmember Karjala said she is confused about what is so embarrassing about Council talking about government and the governing process. She said for those who were embarrassed, this is what Council is supposed to do.

Mayor Miller said she regrets that people were uncomfortable and embarrassed about the tone of the conversation during this item. She said sometimes it sounds like Council is upbraiding Staff in these meetings; however, it is Council's job to oversee what is going on, to legislate, and to do policy. She said she has been doing this for three years and the last few meetings it seems all she has heard is negativity and accusations. She said the City does so many wonderful things for our community every single day and Council is never able to celebrate that because they are tearing things apart all the time. She said Council cannot look at the good that is done and she finds it so distressing. She said Council should be more courteous with one another, more respectful, and treat Staff like the professionals they are. She said Council needs to understand that many things have been done before they became seated as Councilmembers. She said Councilmembers are the leaders of the community and they need to act like leaders although they fell short this evening and she apologized for that. She said Council will come back in January and be ready by studying all the information they have received. She thanked Staff for their hard work and Council for their time.

*

<u>Conference vs. Study Session</u>. Ms. Ann Gallagher, 2513 Woodsong Drive, asked what the difference was between a City Council Conference and City Council Study Session and why are the Council Conferences not televised.

Ms. Brenda Hall, City Clerk, said historically City Council Conferences were not televised because they typically precede a regular Council meeting. She said televising both those meetings back to back can be done but it is somewhat problematic because there has to be enough time between these two meetings to reset the video equipment. She said the pre-meeting Conferences have never been televised.

Mr. Roger Gallagher, 2513 Woodsong Drive, said he appreciated the explanation but it would be very advantageous for people who cannot come to the conference. He said the conference tonight covered important topics regarding the City and the details that Councilmember Hickman asked to be discussed did help the public understand it a little better. He said he wished this could be worked out.

*

<u>Narrowing Main Street</u>. Mr. Roger Gallagher, 2513 Woodsong Drive, said the concept of narrowing Main Street would be a problem because if people want to hurry, they will do it whether there are one, two or three lanes. He said Main Street is a through street to allow access across town and there are not very many. He does not see the advantage of limiting the Main Street traffic to fewer lanes or making it a two-way street. He said people are going to abuse the speed limit no matter what and the City should have no tolerance for speeders.

<u>Development Trends</u>. Mr. Steve Ellis, 633 Reed Avenue expressed concerns about the trends occurring in development with Planned Unit Developments.

Ms. Cindy Rogers, 633 Reed Avenue, said a Planned Unit Development is specifically designed to get around the current zoning.

<u>Need for Toys at the Norman Christmas Day Dinner</u>. Councilmember Clark said for the first time last year, the Norman Christmas Day Dinner ran out of toys for children. She said she would accept donations of unwrapped toys and she would be glad to pick up any toys. She said it is very important that all children have a special Christmas.

<u>Thanks for Attendance Tonight</u>. Councilmember Holman thanked everyone who stayed tonight at the meeting and watched the process.

<u>Lindsey Street Art Grants</u>. Councilmember Allison thanked Council for approving the "We Art Lindsey" Grants provided by the Norman Arts Council which will be an awesome opportunity for the merchants on Lindsey Street.

Stand Alone Senior Center. Councilmember Heiple said he is going to try to give the Seniors a Christmas present. He has a resolution prepared and is going to ask Staff to work on the budget for Norman Forward to get a Stand Alone Senior Center. He said the proposal will be to eliminate or repurpose \$4 million from the parks, \$250,000 each from the Central Library, the Soccer Complex, the Aquatic Complex, and the Baseball/Softball Complex which will total \$5 million. He said Council told the Seniors in the Norman Forward vote that Council would find the money and these are difficult cuts but it would give them the money and then the plan is to ask the Seniors to raise the rest of the money because if a person has the will, there is a way. He said he will hold off on this until he hears from the Senior Community.

ADJOURNMENT

There being no further business, Councilmember Holman moved that the meeting be adjourned, which motion was duly seconded by Councilmember Castleberry; and the question being upon adjournment of the meeting, a vote was taken with the following result:
