In April of 2013 the home of Jason and Kris Abbey at 4511 Chukkar Ct. master bedroom experienced a flood. The following is a detailed account of the statement of circumstances.

- Earlier in the week, the City of Norman had been performing work on the waterline. The contractor dug a trench in the yard leading up to the sewer main. When they concluded the work on the waterline they tried to return the yard back to state of their arrival. One gentleman noted that they tried to get it back as they found it and he apologized if was not as they had found the ground. The angle of the slope from the disturbed ground was much larger than before the work was performed.
- The following evening we experienced a heavy rainstorm. The
  water entered the North East corner of the home. The water was
  substantial enough to heavily saturate the carpet from the NE
  corner to 10 feet into the room.
- Sooner Carpet of Norman was called to assist in the water damage. They removed the padding of the carpet and brought large drying fans and left the fans for several days.
- The following week, we experienced another heavy rainstorm.
   This time the water was at an even greater saturation and dimension of damage into the room.
- Again, the following week, the rain came again and the flooding of the bedroom was astronomical. We had a to use a dry vac to keep up with the flow of water into the bedroom for up to two hours.
- We were forced to remove the carpet, the drywall and some framework to ensure we would not experience affects from the mold that was starting to appear.

We are asking for the city of Norman to assist us in recouping cost associated with this flood that we are certain was the result of the work performed by a contractor hired by the City of Norman.

Please find attached copies of invoices for Sooner Carpet Water restoration and the instillation of a French drain that we were forced to install due to the shift of water drainage from the shift in the slope from the waterline work performed.
