MISCELLANEOUS DISCUSSION

<u>LGBT History Month.</u> Mr. Michael Ferguson, 7201 Nutmeg Drive, thanked the City Council for the vote to make Norman a more inclusive community by declaring October as Lesbian, Gay, Bisexual, Transgender (LGBT) History Month. He said many of the people who do not support LGBT Month are actually silent members.

Ms. Eve Spaulding, 6700 103rd Avenue N.E., read the last portion of the LGBT History Month proclamation. She read several comments she received supporting her belief that this proclamation is not inclusive. She said if Council truly wants an inclusive community, they should not have voted for this proclamation because the subject matter does not join anyone together. She said the people who have spoken against this proclamation have been cursed, made fun of, threatened, and accused of hate and violence. She asked how her belief allows people to blame her for a person's suicide and to say her children should be put to death in front of her. She said the proclamation calls for dignity and inclusiveness and the threats and name calling are not either of those. She said she hoped that Council could look beyond the emotions of this topic and recognize for the good of the entire community, a no vote was the right way to proceed. She said this was just another step towards dividing the community.

Miscellaneous Discussion, continued:

<u>LGBT History Month, continued.</u> Mr. Troy Stephenson, Executive Director of Freedom Oklahoma, said Freedom Oklahoma is a State-Wide LGBT Rights Organization. He apologized to Ms. Spaulding for what she had endured and said nobody should be made to feel that way. He thanked the City Council for doing the right thing because LGBT youth are forced to feel that way every day. He said Council supporting this proclamation made these young people feel like their leaders are behind them.

Mr. Nathan Corbit, 408 West Johnson Street, thanked Council for proclaiming the month of October as LGBT History Month. He said he is sorry that someone threatened Ms. Spaulding's children. He read a speech that he had prepared for this meeting.

Ms. Danielle Finagin, 3016 Conestoga Drive, thanked Council for proclaiming the month of October as LGBT History Month. She said the reason there is so much bigotry is due to a lack of information and allowing people to share those histories and the obstacles that LGBT persons have had to overcome would help that situation.

Ms. Melanie Adams, 909 Goshawk Drive, said not recognizing LGBT History would forsake its truth and those it represents. She said Norman is comprised of diverse people, but there are several LGBTQ members living invisibly due to the climate that was expressed six years ago. She said all have the right to live in a place where they feel part of a community where they can contribute and not feel invisible. She said she feels very touched and moved by Ms. Spaulding's comments because it is not ok to do this, but harmful and ugly.

Dr. James Taylor, 1415 Spoonwood Drive, said he did not support the LGBT Proclamation but by not being in favor of it, he is considered a "hate" person. He said he doesn't hate anybody. He said he does not equate having Black History Month or Hispanic History Month in the same category because those are choices no one has any control over, while there is no historical documentation or medical proof that says people have no choice to be gay. He said the things that were said to Ms. Spaulding as a result of her expressing her opinions are deplorable. He appreciates the effort of Council because it is a very difficult task.

Mr. Sean Braddy, 1406 Kansas Street, thanked Council for allowing the LGBT History Month this evening and that if everyone is not included, then nobody should be included. He said several years ago, he remembered the first Black History Month and many did not appreciate this happening.

Ms. Amanda Revels, 1616 Alameda Street, said she appreciated Council this evening. She said the comments made to Ms. Spaulding were very inappropriate. She said one of the reasons she moved back to Norman was because of the inclusivity brought here due to the University of Oklahoma. She said it is not always a lifestyle choice, it is how we are born.

Ms. Deb Clark, 2134 Summer Drive, thanked Council not just for tonight but for adoption of the Resolution protecting against discrimination associated with an individual's sexual orientation and/or gender identity several months ago. She said she had been extremely moved and when the group at the meeting said the Pledge of Allegiance, she recited it with them and she felt like it included her as well. She said this is the basis for everyone coming together, that there is love underneath it all. She said the relationships that are made are about love. She said this year she joined her partner on their 16th Anniversary of being together and they went to the Courthouse and got married. She said it was very important, she didn't realize how important but it was yet another affirmation that she existed and is real and her love for this other person existed and is real. She said it is very sad that there is bullying on both sides. She loves the sign that says "Building an Inclusive Community" and plans to stay in Norman because she loves Norman.

Councilmember Holman said he was honored to be a part of the LGBT History Month proclamation. He said he believes everyone in his ward knows where he stands on issues and they know his door is always open to anyone no matter what they believe. He said he appreciated all of the comments this evening.

Councilmember Clark said she appreciated all of the comments this evening and thanked those who stayed till the end of the meeting. She is always reminded that she cannot stop being a passionate advocate for the community. She said this proclamation not only recognizes the LGBT History but also Norman's history for attempting to be an inclusive community. She said she ran for City Council to be the voice of a mother of two young children who she wants to grow up in an inclusive community, a voice of a young professional who wants to work in an inclusive community, the voice of her college students who need Norman to be an inclusive community so they can grow into adults who not only respect themselves but respect local government. She speaks for her LGBTQ family, friends, students, and colleagues that deserve an inclusive community.

Miscellaneous Discussion, continued:

LGBT History Month, continued. Councilmember Hickman said as an attorney he has represented LGBTQ children who had been bullied. He said no form of harassment, bullying, mistreatment, of any individual is acceptable and he regrets that it occurred in the past. He hoped in the future, everyone can understand that civil discourse is the proper way to go. He said social media makes it easy to call someone names because it does not seem real but it still hurts people and cause tragic things to happen. He said he is honored to be on this Council and be a leader that his close family members, some who are LGBT, can look up to. He said he appreciated everyone coming this evening and thanked them for their support.

Council member Miller said she understands there are folks in the community who do not feel like the Council needs to be involved in social issues or be involved in funding and recognizing social service agencies but she has not heard that from most of the citizens. For over 40 years, she has taken part in many public dialogues, both large and small, about what we want our community to look like and hears that that people want to be a community that cares about the poor, the abused, the homeless, and the hungry. She said Norman residents care even with Norman's history as a "Sundown" town about protecting the rights of minority groups and as a citizenry, they want to have their voices heard, listened to, and acknowledged. She said City Council care about our safety, relationships with police and fire, schools, hospitals, and our proclamation is the public way that your elected officials recognize all of our citizens that help one another advocate for civil rights for all or want the history of their own group to be recognized and to be respected. She said she believes it is appropriate and she is proud to be part the City Council and the City government that embraces that culture.

<u>Car Seat Education</u>. Councilmember Karjala said there was a nice article in today's paper about Michelle Carr, Jackson PTA, who is showing people how to get their children fitted in their booster seats appropriately. She urged people to read the article.

<u>Lindsey Street Businesses</u>. Councilmember Karjala urged people to stop on Lindsey Street and go to dinner or shop. She said she plans to have an event each month at a different business on Lindsey Street and on Friday, September 30th would be at India Village, 2110 West Lindsey Street, at 6:00 p.m. She urged everyone to come.

<u>National Night Out</u>. Councilmember Holman said although there are not many neighborhoods in Ward 7 that participate in National Night Out, it would be happening on Tuesday, October 4th. He said it was a great way to get to know the people in the neighborhood and the policemen that work the area.

Councilmember Clark said Council tries to attend all of the events that evening and she would love to meet them all. She said the Master Police Officer Thomas Zermeno from the Norman Police Department can help people set up an event.

Councilmember Hickman said he knew of at least two events so far in Ward Four, one in the Old Silk Stocking Neighborhood and one on Lahoma Avenue south of Boyd Street.

<u>Southridge Historic District</u>. Councilmember Hickman said there was a great article in the Norman Transcript about Southridge Neighborhood in Ward Four. He said this area is right across the street from the Mont. He said on October 11th Council will be voting on an application to establish the Southridge Historic District which is the first historic neighborhood voted on in many years.
