STAFF REPORT

ITEM: Consideration of a Final Plat for <u>FOUNTAIN VIEW IV ADDITION</u>, <u>A PLANNED UNIT</u> DEVELOPMENT.

LOCATION: Located at the southeast corner of the intersection of 48th Avenue N. W. and West Tecumseh Road.

HISTORY:

- 1. October 21, 1961. City Council adopted Ordinance No. 1320 annexing this property into the City of Norman.
- 2. <u>December 19, 1961</u>. Planning Commission recommended that this property be placed in the A-2, Rural Agricultural District.
- 3. <u>January 23, 1962</u>. City Council adopted Ordinance No. 1339 placing this property in A-2, Rural Agricultural District.
- 4. <u>February 2, 2012</u>. The Norman Board of Parks Commissioners, on a vote of 8-0, recommended fee in lieu of park land requirements.
- 5. <u>February 9, 2012</u>. Planning Commission, on a vote of 7-0, recommended to City Council amending the NORMAN 2025 Land Use and Transportation Plan from Flood Plain Designation and Very Low Density Residential Designation to Low Density Residential Designation for a portion of this property.
- 6. <u>February 9, 2012</u>. Planning Commission, on a vote of 7-0, recommended to City Council that a portion of this property be placed in the Planned Unit Development and removed from A-2, Rural Agricultural District.
- 7. <u>February 9, 2012</u>. Planning Commission, on a vote of 7-0, recommended approval of the preliminary plat for Fountain View North Addition containing a portion of this property.

- 8. <u>March 13, 2012</u>. City Council amended the NORMAN 2025 Land Use and Transportation Plan removing a portion of this property from Flood Plain Designation and Very Low Density Residential Designation to Low Density Residential Designation.
- 9. March 13, 2012. City Council adopted Ordinance No. O-1112-23 placing a portion of this property in the Planned Unit Development and removing it from A-2, Rural Agricultural District.
- 10. <u>March 13, 2012</u>. City Council approved the preliminary plat for Fountain View North Addition, a Planned Unit Development containing a portion of this property.
- 11. <u>June 14, 2012</u>. Planning Commission, on a vote of 9-0, approved the final plat for Fountain View North Addition, a Planned Unit Development containing a portion of this property.
- 12. <u>March 14, 2013</u>. Planning Commission, on a vote of 8-0, postponed a request to place the remainder of this property in the Planned Unit Development and remove it from A-2, Rural Agricultural District.
- 13. <u>March 14, 2013</u>. Planning Commission, on a vote of 8-0, postponed the revised preliminary plat for Fountain View North Addition, a Planned Unit Development.
- 14. <u>April 11, 2013</u>. Planning Commission, on a vote of 8-0 recommended to City Council amending the NORMAN 2025 Land Use and Transportation Plan from Flood Plain Designation and amending a portion of this property from Low Density Residential Designation to Very Low Density Residential Designation.
- 15. <u>April 11, 2013</u>. Planning Commission, on a vote of 8-0 recommended to City Council placing a portion of this property in the Planned Unit Development and removing it from A-2, Rural Agricultural District.
- 16. <u>April 11, 2013</u>. Planning Commission, on a vote of 8-0, recommended approval of the revised preliminary plat for Fountain View North Addition.
- 17. May 28, 2013. City Council amended the NORMAN 2025 Land Use and Transportation Plan from Flood Plain Designation and amending a portion of this property from Low Density Residential Designation to Very Low Density Designation.
- 18. May 28, 2013. City Council adopted Ordinance No. O-1213-35 amending Ordinance No. O-1112-23, The Fountain View North Planned Unit Development and removing a portion of this property from A-2, Rural Agricultural to PUD, Planned Unit Development.

HISTORY (CONT'D):

- 19. <u>May 28, 2013</u>. City Council approved the revised preliminary plat for Fountain View North Addition, a Planned Unit Development.
- 20. <u>January 30, 2015</u>. The City Development Committee approved the program of public improvements and the final plat for VII Addition, a Planned Unit Development and recommended that they be submitted to City Council with deferral of street paving improvements for 48th Avenue N.W.
- 21. <u>February 24, 2015</u>. City Council approved the final site development plan, final plat and deferral of street improvements for VII Addition, a Planned Unit Development.
- 22. <u>April 14, 2016</u>. Planning Commission, on a vote of 7-0, recommended to City Council amending the site plan and PUD narrative.
- 23. May 24, 2016. City Council adopted Ordinance No. O-1516-31 amending the site plan and PUD narrative adopted with Ordinance No. O-1213-35.

IMPROVEMENT PROGRAM:

- 1. Fencing. Fencing will be installed adjacent to Tecumseh Road and 48th Avenue N.W.
- 2. <u>Fire Hydrants</u>. Fire hydrants will be installed in accordance with approved plans. Their locations have been approved by the Fire Department.
- 3. <u>Permanent Markers</u>. Permanent markers will be installed prior to filing of the final plat.
- 4. <u>Sanitary Sewers</u>. A sanitary sewer main will be installed in accordance with approved plans and City and Department of Environmental Quality standards to serve the proposed lots.
- 5. <u>Sidewalks</u>. Sidewalks will be constructed adjacent to 48th Avenue N.W.
- 6. <u>Storm Sewers</u>. Storm sewers and appurtenant drainage structures have been installed in accordance with approved plans and City drainage standards. Storm water will be conveyed to an existing off plat detention facility within Fountain View North Addition.
- 7. <u>Streets</u>. Currently 48th Avenue N.W. is designated as a minor arterial street and will be constructed as a collector street. Staff is recommending deferral of the street paving improvements.
- 8. <u>Water Mains</u>. There are existing twelve-inch (12") water mains adjacent to West Tecumseh Road and 48th Avenue N.W.

PUBLIC DEDICATIONS:

- 1. <u>Easements</u>. All required easements are dedicated to the City on the final plat.
- 2. Rights-of-Way. All street rights-of-way are dedicated to the City on the final plat.

SUPPLEMENTAL MATERIAL: Copies of a location map, preliminary plat, final site development plan and final plat are attached.

STAFF COMMENTS AND RECOMMENDATION: The engineer for the developer has requested the City Development Committee review the final plat for Fountain View IV Addition, a Planned Unit Development and submit it to City Council for consideration.

This property consists of 8.83 acres, 4 large single family residential lots. The Development Committee supports the final plat for Fountain View IV Addition, a Planned Unit Development with deferral of street paving improvements for 48th Avenue N.W. and recommends the final site development plan and final plat be submitted to City Council for its consideration. Traffic Impact fee for the traffic signal at West Tecumseh Road and 48th Avenue N.W. has been determined to be \$175.00. Deferral of street paving improvements for 48th Avenue N.W. is determined to be \$69,532.70.

The final plat is consistent with the approved revised preliminary plat with reducing from seven (7) to four (4) lots and the elimination of a private street.
