WHEREAS, the Norman Municipal Authority (the "Authority") has under consideration the issuance of its Sales Tax Revenue Note, Series 2020 in the approximate principal amount of \$22,250,000 (the "Note") for the purpose of (i) financing all or a portion of the costs of certain quality of life improvements (Norman Forward) benefitting the residents of the City, along with related costs (collectively, the "Project"), and (ii) paying costs associated with the issuance of the Note; and

WHEREAS, it is deemed desirable for the Authority to give preliminary authorization for the issuance of the Note.

NOW, THEREFORE, BE IT RESOLVED BY THE TRUSTEES OF THE NORMAN MUNICIPAL AUTHORITY:

<u>SECTION 1. PRELIMINARY AUTHORIZATION.</u> The Authority authorizes Municipal Finance Securities, Inc., as the Authority's Financial Advisor, to distribute bid packages to financial institutions in connection with the proposed sale of the Note.
