MISCELLANEOUS DISCUSSION

Storm Shelters. Mr. Mark Campbell, Post Office Box 1531, said he was disappointed with Council's decision to stop promoting the schools as storm shelters. He said most severe weather develops in the afternoon when people are at work or school and having buildings open during a storm is not the same as designating or advertising them as storm shelters. He urged Council to leave the buildings open, but not advertise them as storm shelters. He said during the May tornado, the Library closed and made people leave and busses kept running even though there were no plans on where riders would go if the tornado hit. He said the City should be involved in decisions on whether or not to close the Library or stop busses from running during severe weather instead of leaving those decisions solely to the agencies that operate them. He said the Library is a City building and he does not understand why the City does not have some jurisdiction in decisions on closing the Library during severe weather.

National Night Out. Councilmember Holman said he enjoyed National Night Out on October 1st. He met a number of new people and enjoyed the conversation and food.

Councilmember Griffith said he enjoyed National Night Out as well. His Ward held nine events and he attended six of those events. He thanked the Norman Police Department for escorting him to the events allowing him to attend as many as time allowed. He thanked the District Attorney's (DA) Office and said this is the first year DA Staff has attended the events. He also thanked the Animal Welfare Division for attending and discussing improvements being made to the Animal Welfare Facility and thanked the Fire Department because they were always the hit of the party when they arrived in fire trucks.

Councilmember Castleberry echoed previous comments about National Night Out. He said there were five parties in his Ward that were very well attended and thanked the Mayor for attending a couple of them. He appreciated the citizen feedback and said it was nice to hear that many people think the City is doing a good job.

Miscellaneous Discussion, continued:

National Night Out, continued. Councilmember Williams said National Night Out is his favorite time of the year. He always enjoys meeting new people and eating the wonderful food they provide. He said his Ward held nine events and he attended them all and thanked the Mayor for attending a few. He thanked the Police and Fire Departments as well as citizens who attended and hosted the events. He thanked the City Manager for helping resolve two issues that were brought to his attention at the events and said if the City is not aware there is a problem, they cannot fix it and encouraged citizens to call their Councilmember or City Hall to report problems.

Councilmembers Miller and Heiple said National Night Out was great and they had good time.

Mayor Rosenthal thanked Deputy Police Chief Jim Maisano for escorting her to the many National Night Out events. She said moving the event from August to October made it a huge success and many constituents urged the City to keep the event in October.

Business and Community Affairs Committee. Councilmember Castleberry thanked Professor Cindy Rogers for inviting Dr. Carlianne Patrick of the Department of Economics, Georgia State University, to make a presentation to the Business and Community Affairs Committee regarding economic development and clawback agreements. He said it was nice to hear from an expert that Council did some things right in regards to the Norman Economic Development Authority and that the City is moving in the right direction on economic development.

Norman Public Library Flooring Replacement Project. Councilmember Miller said an item on the consent docket may have seemed obscure to many people, but is a big deal to her. The Library will be getting new flooring, which is badly needed. She said the City has made a lot of recent improvements to the Library building that included a new heat and air system and new lighting throughout the building.

<u>Crop Walk for Hunger</u>. Councilmember Heiple said approximately 700 people attended the Crop Walk for Hunger event. He said it was a fun time and encouraged citizens to attend next year's event. He said there are at least 200 to 300 people that do not have a place to go to at night and this is an issue that needs to always be considered.

Norman Regional Hospital. Councilmember Heiple said when Norman Regional Hospital submitted their annual budget to the City, he had asked if them if they could provide prices for the twenty most common procedures they perform and they could not. He and Councilmember Miller recently met with hospital Administrative Staff to discuss this and found there is no simple solution. He said the City of Norman has the best community hospital in the world and if health care is going to be fixed, it has to start in our own back yard because federal and state governments are not going to do it. He hopes within twelve months the hospital will be able to list prices they have for some medical procedures. He thanked Norman Regional Staff for their assistance as well as Councilmember Miller and constituents who attended the meeting. He said if anyone wants to be a part of these discussions, feel free to contact him.

City Manager's Report

Sewer Rate Increase Election. A Special Election for a sewer rate increase will be held on November 12, 2013. Those rates will be used to finance the expansion of the Water Reclamation Facility. Citizens will be receiving an informational brochure in the mail soon and the information is posted on the City's website. He said if citizens have questions, please contact the Action Center.

Road Improvements. Construction seems to happening everywhere and I-35 and Lindsey Street will soon be added. Many citizens ask what is happening on Highway 9 between 24th Avenue and 36th Avenue. He said there have been a lot of utility relocations as part of a project that the Oklahoma Department of Transportation (ODOT) is sponsoring to construct a four-lane urban section with divided median, curbs, and shoulders. That project is scheduled to be bid in December 2013, with improvement beginning in March 2014, with an estimated construction period of one year.

Miscellaneous Discussion, continued:

City Manager's Report, continued:

Many motorists have been trying to navigate around the closure of the Indian Hills Road Bridge at I-35. This is a project where Norman has partnered with ODOT to make major maintenance repairs to the bridge deck and the project should be completed by Friday, October 11th. The maintenance should sustain the bridge for ten years, but the City and ODOT are in the process of scheduling rebuilding that interchange within the eight year plan.

Budget. The total General Fund Revenue Budget is \$37,700,000 for FYE 14 and \$9,073,000 was projected for the first three months of revenue; however, \$9.4 million has been collected to date, an increase of 4 1/2 % on sales tax revenue. Use taxes have increased by 22% and although franchise taxes have decreased they are above last year's figures. Other taxes have increased by \$300,000 due to a Federal Emergency Management Agency (FEMA) reimbursement. In July sales tax increased by 3.6%, 5.9% in August, and 5.3% in September 2013.

Expenditures have been projected to be \$8 million to date, but only \$7.4 million has actually been expended.

License and permit revenues have increased while fines and forfeitures have decreased. Expenditures are creeping ahead of revenues and that is a chronic issue the City is trying to address.

Hotel/Motel revenues have increased because of the room tax increase voters approved recently, but there has also been an increase in occupancy because of the May 31st tornado, housing victims of the tornado as well as contractors involved in clean up and rebuilding efforts.

Residential water revenues have had a dramatic decrease from last year, but the City is comparing very dramatic years. He said the summer of FYE 14 has been very moderate and is the fourth or fifth wettest year in Oklahoma while FYE 13 was one of the driest years. Emergency water was purchased from Oklahoma City, which is not reflected in the revenue figures and that would offset the revenues. The City is monitoring the Water Fund carefully and because it is capital intensive, some projects may have to be readjusted.

Mayor Rosenthal said although it is very early in the fiscal year, Council needs to be vigilant in monitoring the budget and not change course. She said, typically, budget adjustments are made mid-year after the audit is complete so Council has three months to review proposed adjustments.
