Norman Forward. Mr. Mark Campbell, 517 North University Boulevard, said citizens have 21 days the Norman Forward election on October 13, 2015. He said Council has an obligation to put seniors first and should take the time to work on a stand-alone senior center. He said an organized, respectful group is asking Council to consider and comment publicly on their professionally designed stand-alone Senior Citizens Center. He said there is a Facebook page, Friends for a 21st Century Senior Citizens Center, with 550 petitioners requesting a stand-alone senior center.

Mr. Bobby Stevens, Post Office Box 6226, said Council has had time to decide if senior citizens will have a stand-alone center. He said citizens are trusting Council to do the right thing for the community as well as senior citizens. He said there are other issues in Norman the money could be spent on, such as obtaining future water sources. He said there are better locations for the proposed central library than near the railroad tracks. He feels the Norman Forward package was rushed through and he will not vote for this package on election day.

Councilmember Castleberry said Council can handle more than one issue at a time as the City is working on the Storm Water Master Plan, road improvements, a stormwater utility, etc. He said what he likes about Norman Forward is that it is a citizen based initiative and the senior citizens have had an active part in discussions during the entire process as well the advocates for soccer, Pisces, basketball, baseball, football, etc. There are some items Council trimmed down during the process and Council chose those proposals that would have the most impact on the entire community. He asked citizens to look at the overall package even if they do not like some of the proposals. He said the ballot language is set and cannot be changed and he encouraged citizens to hold Council accountable going forward.
