AN ORDINANCE OF THE COUNCIL OF THE CITY OF NORMAN. OKLAHOMA, AMENDING SECTION 460 OF CHAPTER 22 OF THE CODE OF THE CITY OF NORMAN SO AS TO REMOVE LOTS SEVEN (7), EIGHT (8), AND NINE (9), IN BLOCK SIXTEEN (16), OF THE ORIGINAL TOWN OF NORMAN, CLEVELAND COUNTY, **OFFICE** OKLAHOMA, **FROM** THE CO, **SUBURBAN** COMMERCIAL DISTRICT AND PLACE THE SAME IN THE R-3. MULTI-FAMILY DWELLING DISTRICT, OF SAID CITY; AND PROVIDING FOR THE SEVERABILITY THEREOF. (213 E. Tonhawa Street)

- 8 1. WHEREAS, Nicholas Robert Corporation has made application to have the subject property removed from the CO, Suburban Office Commercial District, and to have the same placed in the R-3, Multi-Family Dwelling District; and
- § 2. WHEREAS, said application has been referred to the Planning Commission of said City and said body has, after conducting a public hearing as required by law, considered the same and failed to recommend that the same should be granted and an ordinance adopted to effect and accomplish such rezoning; and
- § 3. WHEREAS, the City Council of the City of Norman, Oklahoma, has thereafter considered said application and has determined that said application should be granted and an ordinance adopted to effect and accomplish such rezoning.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORMAN, **OKLAHOMA:** 

That Section 460 of Chapter 22 of the Code of the City of Norman, Oklahoma, is hereby § 4. amended so as to remove the following described property from the CO, Suburban Office Commercial District, and to place the same in the R-3, Multi-Family Dwelling District, to wit:

> Lots Seven (7), Eight (8) and Nine (9), in Block Sixteen (16), of the ORIGINAL TOWN of Norman, Oklahoma, according to the recorded plat thereof.
