CONTINUED DISCUSSION REGARDING A POTENTIAL INCREASE IN THE TRANSIENT GUEST ROOM TAX

- Committee discussed whether to raise the hotel/motel room tax rate by 1%, 1.5% or 2%.
- Disadvantage to City hoteliers if rate is higher than Oklahoma City or Tulsa and surrounding communities.
- Koranda stated that an increase above the Oklahoma City and Tulsa rate will hurt the chances of hosting large groups
- Kathryn Walker reviewed draft ballot and told the group once the Council decides on the rate increase to ask for, it can be plugged into the ballot.
- If ballot should fail, how soon can it be presented again to the citizens for a vote?
- Consensus of the Committee to move forward with an election in April asking for a 1% increase.

DISCUSSION REGARDING THE PHASE II CAPITAL IMPROVEMENTS FOR THE SOUTHSIDE WATER RECLAMATION TREATMENT PLANT

Ken Komiske made presentation.

- Reviewed previous presentation.
- Dialogue with DEQ for the past 12 to 13 months.
- Engineering Report/Conceptual Design for plant was submitted to DEQ in November 2011.
- Do not have approval of engineering report at this time.
- City's current average daily flow is 11 mgd which is 92% of capacity.
- New requirements include disinfection and dissolved oxygen.
- DEQ insists that disinfection process must be addressed.
- Current plans call for building a facility that will be able to handle 17 mgd which represents full build-out of South Basin according to 2025 Land Use Plan.
- This is a \$50 million to \$60 million project.
- Timeline for DEQ compliance was reviewed and discussed.
- Phase 2 design would have to be completed in order to be prepared to construct Phase 3 which will allow the City to produce "drinking water" quality water.
- Francisco plan is to build facility with 17 mgd capacity even though only allowed to discharge 16 mgd, correct?
- Discussed General Obligation Bonds and Revenue Bonds and which will be better for City to pursue. Depends on interest rate and when Council decides to proceed with election.
- Financial experts predicting possible "spike" in interest rates in two to three years.
- Discussed elections calendar and when would be best for City of Norman.
- Consensus to have an election in November of this year for the Phase II Improvements on the Southside Wastewater Treatment Plant.
