



TEMPORARY CONSTRUCTION EASEMENT DESCRIPTION FOR PARCEL 5.0

LEGAL DESCRIPTION:

A strip of land lying in the Southwest Quarter (SW/4) of Section 33, Township 9 North, Range 2 West of the Indian Meridian, Cleveland County, Oklahoma. Said parcel of land being described as follows:

Lot Four (4), in Block Two (2), of Colonial Estates No. 4 Addition to the City of Norman, Cleveland County, Oklahoma, according to the recorded plat thereof.

EASEMENT DESCRIPTION:

Commencing at the southwest corner of Block Two, Lot Four of said Colonial Estates No. 4 Addition; thence east along the said south parcel line a distance of 34.00 feet; thence north perpendicular to the said south parcel line a distance of 16.00 feet; thence west parallel to the said south parcel line a distance of 34.00 feet; thence south perpendicular to the said south parcel line a distance of 16.00 feet to Point of Beginning.
