Item 1, being: Call to Order

Chair, Mayor Lynne Miller, called the meeting to order at 2:34 p.m.

### Item 3, being:

Consideration and appropriate action to approve the minutes of the November 6, 2017, special meeting of the Norman Center City Project Review Committee

County Commissioner Harold Haralson moved to approve the minutes and the motion was seconded by Chuck Thompson. Mayor Lynne Miller called the vote: all in favor and none opposed.

### Item 4, being:

Presentation, discussion, and possible appropriate action on the proposed Norman Center City Project Plan, Eligibility Report, and Financial Impacts Report

Ms. Emily Pomeroy referred the Review Committee members to the Powerpoint handout. She discussed the Committee's previous appointment of a sub-committee in order to further review financial projection information. The sub-committee consisted of the following members: Harold Haralson, Chuck Thompson, Bob Thompson and Mayor Lynne Miller. The sub-committee met on November 13, 2017, and made the recommendations shown in redline in the Project Plan, to be reviewed by the full Review Committee at this meeting so that any additional questions from members can be addressed. The sub-committee recommended there not be a sales tax increment district created largely based on discussion during the sub-committee meeting about the nature of this type of project and the lack of significant sales taxes likely to be generated.

Also during the sub-committee meeting, a recommendation was made that a \$3,000,000 frontend City commitment that was in the previous version of the Project Plan remain and that it specify it not be reimbursable with incremental revenues funds and it will it be a one-time commitment, rather than a revolving fund. The sub-committee recommended that it be funded with available municipal sources and be a front-end investment by the City. This change is reflected in Section IX(A) of the Project Plan.

Ms. Pomeroy pointed out additional language that was added upon the recommendation of the sub-committee that more directly ties the public improvements contemplated in the Project Plan to the Johnson & Associates Infrastructure Analysis. This is to clarify that the Project Plan is not proposing that increment be used to fund regular maintenance and upkeep of City improvements, but will be used on infrastructure improvements consistent with the Center City Form-Based Code that the City adopted earlier this year. That change is reflected in Section VIII(B) of the Project Plan.

Highlighted by the sub-committee was the importance of public improvements along James Garner Avenue, how it will encourage private investment along the street and has the potential to contribute positively to the success of the Project Plan. Also, a change is reflected in Section IX(D) which is to make specific statutory reference to the requirements for annual reporting.

Mr. Haralson provided members with charts that outline the City's historical property growth rates. This information was compiled by the County Assessor, Douglas Warr, and includes figures that were used in the projections of increment generation.

### Item 5, being:

Possible consideration and appropriate action to approve the Findings and Recommendation of the Norman Center City Project Review Committee

Mayor Miller asked the Committee if there were any further comments or questions regarding the Project Plan, with the revisions recommended by the sub-committee. Mr. Haralson reported that the Board of County Commissioners voted on November 20, 2017, to recommend that the Review Committee approve the Findings and Recommendation. Mr. Haralson moved that the Review Committee approve the Findings and Recommendation of the Norman Center City Project Review Committee. Mr. Chuck Thompson seconded the motion, and provided an expression of appreciation to the Review Committee, both as an at-large member and as acting chairman of the Pioneer Library System, on behalf of Lisa Wells. The Mayor called the vote, and the motion passed unanimously, all in favor, none opposed.

Ms. Pomeroy thanked the Review Committee for its time, service, and assistance in its review of the Project Plan, and reported that the Project Plan, with the proposed amendments, the Financial Impacts Report, the Eligibility Report, and the Findings and Recommendation of the Norman Center City Project Review Committee will be presented to City Council on December 5, 2017, for a public hearing and first reading of an ordinance approving and adopting the Norman City Center Project Plan.
