# CITY OF NORMAN Agreement for Professional Spay and Neuter Services

This Agreement, made and entered into this 13 day of JAN, 2015, between the City of Norman, a municipal corporation (the "City"), and Best Friends of Pets Spayway Clinic (the "Clinic");

WHEREAS, the City owns and operates the Animal Welfare Center, a center located in Norman that serves, among other things, as a shelter for pets and facilitates adoptions for said pets; and

WHEREAS, the Animal Welfare Center ("AWC") is currently undergoing renovation and expansion and currently lacks a surgery area available for use for spay and neutering animals; and

WHEREAS, the City sought proposals for Offsite Spay and Neuter services for adoptable dogs and cats to be provided at least through the completion of the renovation and expansion construction project currently underway at the Center, which is anticipated to be completed in the summer of 2015; and

Now, THEREFORE, in consideration of the promises containing herein, the Parties hereto agree as follows:

#### I. Obligations of the Clinic:

- A. Spay and Neuter Services: The Clinic shall provide spay, neuter and related services on dogs and cats on the same day in which they are delivered.
- B. All animals delivered to the Clinic for spay and neuter services shall also b given a health examination, with any health concerns being indicated on the Clinic admission form.
- C. All animals that are spayed and neutered under this Agreement shall be tattooed near the incision site to indicate the animal has been spayed/neutered.
- D. All animals delivered to the Clinic shall also receive needed rabies and core vaccinations, nails shall be trimmed as needed, and a microchip shall be placed in the animal.
- E. All such services shall be provided at the price provided in the Clinic's proposal, attached hereto as Exhibit A.
- F. The Clinic will invoice the City each day for services performed.

#### II. Obligations of the City:

- A. AWC Staff will deliver adoptable dogs and cats to the Clinic up to three (3) days per week between 8:00 a.m. and 10:00 a.m. as needed for spay/neutering services and other services as described herein. No more than ten (10) animals will be delivered on any one day. "Adoptable dogs and cats" are those dogs and cats that have been placed in a foster home for at least ten (10) days prior to treatment and are in good health.
- B. Prior to delivery of dogs and cats to the Clinic, AWC Staff will perform pretesting for heartworms, Lyme, and feline immunodeficiency virus.
- C. AWC Staff will return to the Clinic and pick up any animals that were delivered to the Clinic at the end of same business day or at a time mutually agreeable to the parties.
- D. AWC Staff will communicate with the Clinic regarding number of animals requiring services on a particular day and the expected delivery and pick up times.
- E. Invoices for services performed by the Clinic shall be paid no later than thirty (30) days from the date of receipt.
- III. <u>Term</u>. The initial term of this Agreement will expire on June 30, 2015, with an option to renew for the following year until completion of construction at the Center subject to the Clinic's satisfactory performance and the availability of appropriated funds in Fiscal Year Ending June 30, 2016.
- IV. <u>Termination</u>. This contract may be terminated at any time, with or without cause, upon thirty (30) days written notice to the other party.

#### V. General Provisions

- A. Clinic shall perform in a good and professional manner the services identified in the Agreement. This Agreement shall include the Request for Proposals issued by the City, the Clinic's Response to the Request for Proposals, and this Agreement. If any conflict exists between these documents, this Agreement shall control.
- B. Clinic warrants that it understands the currently known hazards and suspected hazards which are presented to persons working with animals. Clinic further warrants that it will perform all services under this Agreement in a safe, efficient, and lawful manner using industry-accepted practices, and in full compliance with all applicable State and Federal laws governing activities under this Agreement.

C. <u>Notice</u>: Any notice, demand, or request required by or made pursuant to this Agreement shall be deemed properly made if personally delivered in writing or deposited in the United States mail, postage prepaid, to the address specified below:

Nothing contained herein shall be construed to restrict the transmission of routine communications between representatives of the City and the Clinic.

D. Indemnification: The Clinic agrees to defend, indemnify, and hold harmless the City, its officers, servants, and employees, from and against any and all liability, loss, damage, cost, and expense (including attorneys' fees and accountants' fees) caused by an error, omission, or negligent act of the Clinic in the performance of services under this Agreement. City agrees to defend, indemnify, and hold harmless the Clinic, its officers. servants, and employees, from and against any and all liability, loss, damage, cost, and expense (including attorneys' fees and accountants' fees) caused by an error, omission, or negligent act of the City in the performance of services under this Agreement, provided such indemnification shall be applicable only to the extent sovereign immunity has been waived pursuant to Oklahoma law. The Clinic and the city each agree to promptly service notice on the other party of any claims arising hereunder, and shall cooperate in the defense of such claims. The acceptance by City or its representatives of any certification of insurance providing for coverage other than as required in this Agreement to be furnished by the Clinic shall in no event be deemed a waiver of any of the provisions of this indemnity provision. None of the foregoing provisions shall deprive the City of any action, right, or remedy otherwise available to City at common law.

#### PROPOSAL FOR OFFSITE SPAY AND NEUTER SERVICES FOR ADOPTABLE DOGS

#### **General Background**

Best Friends of Pets, Inc. (Best Friends), 720 W. Wilshire Blvd, Suite 101-F, PO Box 415, Oklahoma City, OK 73101-0415, (405) 418-8511, is a nonprofit organization. Best Friends operates our SpayWay spay/neuter clinic, which provides spaying/neutering, vaccinations and microchipping to pet owners with gross household income of \$50,000 or less, rescue groups and select animal shelters.

SpayWay (405) 414-8142 is currently located at A New Leash on Life center (New Leash) at 7949 S. I-35 Service Rd., Oklahoma City, OK 73149. In early 2015 we expect to move to a new location at Western and I-240. A lease for the new space is currently being negotiated.

Our SpayWay clinic is capable of handling 40-60 animals each service day.

#### Vendor Qualifications, Experience and References

Space being used at New Leash consists of a surgery room of about 220 square feet and two holding rooms about 500 square feet each. Our dog holding area has more than 25 cages. Cats are usually kept in their carriers before and after being spayed or neutered. Our new location will have 1,750 square feet and will be built-out to our specifications with a surgery suite, dog and cat holding rooms, an office, breakroom and lobby. We are in the process of seeking funding for more cages.

Our SpayWay staff includes the following:

- Terry Yunker, DVM Dr. Yunker is a contract veterinarian with our SpayWay clinic. He has performed more than 50,000 spays and neuters for organizations including The Montana Spay/Neuter Task Force, Davis Oklahoma Animal Volunteers, Volunteers for Animal Welfare SPOT Clinic and Spay Oklahoma in Tulsa.
- Arlene Buchanan, clinic manager and veterinary assistant, is a full-time employee.
- Samantha Gates, veterinary technician, is a full-time employee.

A health examination is included in our spay/neuter prices. Any health concerns about each animal will be indicated on our admission form (see attached). Each animal spayed or neutered will receive a small (1/4 to 1/2 inch) line of green tattoo ink close to the incision site. Nails will be trimmed as needed. There will be no charge for administering vaccines and implanting microchips provided by Norman Animal Welfare Center.

#### Frequency of Services

Per Week: SpayWay can receive animals three (3) days a week.

Per Service Day: SpayWay can perform up to ten (10) spays/neuters for Norman Animal Welfare Center in a service day.

#### **General Requirements**

#### BEST FRIENDS OF PETS SPAYWAY CLINIC

Appointments are required to be made for all animals coming to our SpayWay clinic. We are able to receive animals from Norman Animal Welfare Center between 8:00 a.m. and 10:00 a.m. and are able to work with Employees of the Center to ensure that pets are ready to be picked up at the end of the day. We request that approximate delivery times be communicated to our staff when appointments are made so we can be ready to receive the pets. We begin spaying and neutering pets early in the morning so our clinic manager needs to be prepared to break from her veterinary assistant duties to check in animals. We request that pick up times be communicated to our staff so we can rearrange the order of spays and neuters as needed to ensure that pets are sufficiently recovered from their surgeries prior to being transported.

An admission form will be completed for each animal (see attached), which reflects information about each animal and services performed. Invoices will be prepared showing the name or identification number of each pet receiving services that day and the total amount due. Invoices will be given to the Employee of the Center picking up the animals unless the Center requests that invoices be mailed or emailed to a designated Employee.

All animals from the Norman Animal Welfare Center will be required to be out of the shelter and at a foster home for at least ten (10) days and be in good health before coming to our SpayWay clinic. This minimum time period will help ensure that the animal has not developed a contagious disease that it might have been exposed to while at the shelter. All animals that come to our clinic must be in good health so as not to expose other pets to contagious diseases. Any animals suspected of being ill must be removed immediately.
