MEETING MINUTES

NORMAN ELECTION COMMISSION MINUTES

January 5, 2015

The Norman Election Commission of the City of Norman, Cleveland County, Oklahoma, met in the Municipal Building Conference Room at 201 West Gray on the 5th day of January, 2015, at 2:15 p.m. Notice and agenda of the meeting were posted at the Municipal Building 48 hours prior to the beginning of the meeting.

Item 2. Approval of minutes from the October 20, 2014, meeting. Member Windes moved that the minutes from the October 20, 2014, meeting be approved, which motion was duly seconded by Member Hilbert;

and the question being upon approving the minutes from the October 20, 2014, meeting, a vote was taken with the following result:

Chairman Hardiman declared the motion carried and the minutes from the October 20, 2014, meeting was approved.

Item 3. Election of Chair and Vice-Chair. Member Windes moved that Chairman Hardiman and Vice-Chairman Hilbert be reelected, which motion was duly seconded by Member Hilbert; there being no further nominations it was declared Chairman Hardiman and Vice-Chairman Hilbert were reelected by acclamation.

Item 4. Review of Ordinance No. O-1415-23 amending Chapter 7.5, Elections, (City Council campaign reports) to comply with changes in State Law established under the Municipal Campaign Finance and Financial Disclosure Act including the new State regulations for municipal candidates, candidate committees, municipal political committees, and municipal elected officials.

Chairman Hardiman said Senate Bill (SB) 1745 eliminates the Political Subdivisions Ethics Act and creates three new state statutes regulating the conduct of campaigns for counties, technology center/independent school districts, and municipal elections and gives the Ethics Commission the authority to promulgate specific rules governing such conduct as well as the authority to enforce them.

Item 4, continued:

Chairman Hardiman said the Norman Election Commission's (NEC) role in elections will change because municipal campaign reports will no longer be allowed. He said NEC will continue to review state campaign reports and help to facilitate distribution of information to voters regarding municipal elections so they have the best information to make the most informed decisions. He said NEC will also continue its current duties of educating the public and reporting to City Council as he did not believe the education process would be prohibited under the Municipal Act.

Chairman Hardiman said City Council approved Ordinance No. O-1415-23 amending Chapter 7.5. Elections, on November 25, 2014.

At that meeting, some Councilmembers wanted to leave the ordinance as is in hopes the State law would change and the City's ordinance would not be out of compliance; however, that seemed to be an awkward solution to other Councilmembers who felt it would be confusing for candidates. He said Council could revisit the ordinance if State law changed and Ms. Brenda Hall, City Clerk, agreed. Ms. Hall said on December 9, 2014, Council adopted Resolution No. R-1415-63 asking the State Legislature to consider modifying the law allowing municipalities to have local rules in addition to the State's. Chairman Hardiman said the resolution shows Council's support for NEC and NEC appreciates that support. (Member Hilbert said he would support a letter being sent from the NEC as well and Chairman Hardiman suggested Ms. Hall work with the Legal Department to compose a letter to be submitted for NEC).

Ms. Hall said the amended ordinance removes all the local reporting requirements and modifies the City Clerk's and NEC's duties to align with new State laws. Ms. Hall said the NEC reporting cycles were left in the ordinance because the City did not know all of the State rules at the time the ordinance was being amended. She said because of that, the City's calendar timeline does correlate to the State's reporting deadlines and Council may have to revisit that section of the ordinance, but NEC will need to work with dates the best they can.

Item 5. Consideration and discussion of candidate packet materials and the process for the Candidate Orientation Session.

Ms. Brenda Hall, City Clerk, said the candidate orientation meeting is scheduled for January 21, 2015, at 6:00 p.m. She said all seated Councilmembers will be impacted by the new rules as well and have been invited to attend the orientation. She said report filing will take place year round even if the Councilmember is not in an election so, as a result, NEC's meeting dates will also change and highlighted the new meeting dates.

Ms. Hall said all candidates and seated Councilmembers will be provided a Guide for Municipal Candidates (manual) prepared by the Oklahoma Ethics Commission. She said they will also be provided information regarding political sign regulations; the role of NEC; report requirements and deadlines; candidate committees; municipal political committees; duties of treasurer; campaign depositories; financial disclosure statements; contributions; contributions imits; loans; in-kind contributions; contributions and expenditures; and disclosure requirements.

Item 5, continued:

Chairman Hardiman said, in the past, the City provided a Frequently Asked Questions (FAQ) sheet and asked if that is still part of the orientation and Ms. Hall said no, it will not be included because the FAQ reflected the old procedures. She said the State has not created a FAQ, but the manual is pretty self-explanatory. Ms. Hall said State forms are being prepared and should be available prior to the orientation.

Chairman Hardiman said it appears that a candidate or candidate committee supporting or opposing candidates do not have to file a report if they do not expend more than \$1,000 and Ms. Hall said that is correct. She said the threshold used to be \$500 at the State level while former City rules required filing a report if any monies were expended. She said there will be a few candidates that do no more than pay their filing fees so those candidates will not file a report. Chairman Hardiman felt when the threshold was \$500, NEC had the authority to find anyone that distributed campaign materials, some being slanderous/libelous, and require them to file a report, but now someone can distribute mailers and flyers and if they spend under \$1,000 they are basically given a free pass.

Ms. Hall said committees registered with the State, such as the Realtors Political Action Committee (PAC), only have to file at the State level and will not be handled at the local level. She said NEC can work on those types of items as they come up.

Ms. Hall said every candidate will be required to have a Campaign Committee, which will be the only committee authorized by a candidate to accept contributions or make expenditures on behalf of the candidate's campaign. A Campaign Committee must have a Chair and Treasurer, which can be the same person serving as both and appointment of a Deputy Treasurer, is optional. The Treasurer is legally responsible for keeping the Campaign Committee's/PAC financial records and accounts including all contributions accepted; all deposit slips or other evidence of acceptance of contribution; all expenditures made; all receipts, canceled checks or other evidence of payment of expenditures; and all other documents necessary to file reports of contributions and expenditures. The Treasurer must also maintain records for a period of four years to be made available to the Ethics Commission. Every Campaign Committee must establish at least one campaign depository in a financial institution that ordinarily conducts business in the State of Oklahoma and all contributions must be deposited in the account within ten days of receipt. All expenditures made by the Campaign Committee must be made by check or debit card signed by the Treasurer. Chairman Hardiman felt these rules would discourage many people, such as college students, from running for City Council because of the Treasurer's being legally responsible for the flow of money and the opening of a bank account. He said the difficulty level will discourage some people from participating in the process. Ms. Hall said those candidates that are not going to spend money on their campaign are going to be the same people that only pay their filing fee and will not meet the \$1,000 threshold so they will not have to meet these requirements.

Chairman Hardiman asked if every person on Council will have to file a quarterly report and Ms. Hall said active candidates will file on different dates than seated Councilmembers that are not involved in an election and she highlighted those report dates. She said all candidates are required to file a Financial Disclosure Statement with the City Clerk at the same time he or she files a Statement of Organization for a Campaign Committee. Current elected municipal officers are required to file a Financial Disclosure Statement no later than May 15 of each year as long as they remain candidates. Chairman Hardiman asked if the Financial Disclosure Statement is considered a quarterly report or a post-election report and Ms. Hall said it is an annual report that once seated the candidate files annually due May 15th. She said this report has nothing to do with contributions or expenditures it is a report on the candidates personal financial holdings valued over \$5,000. She said the State has always required a Financial Disclosure Statement for State campaigns, but it has not been required at the local level. Local candidates are not being asked to do anything different than what current State representatives, State employees who purchase equipment, and State Board Members have been doing for years.

Item 5, continued:

Chairman Hardiman asked if Ms. Hall would include the Financial Disclosure Statement date on the report due date page for the orientation meeting and she stated she would add that date to the page.

Ms. Hall said corporate and labor union contributions are prohibited and limited liability companies and partnerships may contribute as long as none of its members is a corporation. Cash contributions can be no more than \$50 and a maximum anonymous contribution can be no more than \$50. The maximum contribution from an individual is \$2,600 for each election in which the candidate's name appears on the ballot. The maximum contribution from an individual to a candidate who is unopposed is \$2,600. Limited committees and Municipal PACs may make contributions of \$5,000, unless the committee was formed within the past year with fewer than 25 members, then the contribution limit is \$2,500.

Contributions are deemed to have been accepted by a candidate if not returned within ten (10) business days. A contribution that has not been deposited within ten (10) business days must be returned to the contributor and reported as having been received and refunded. An individual who hosts a fund-raising event for a candidate and uses personal funds may spend up to \$1,000 before the expenditure is considered an in-kind contribution to the candidate's campaign. Any amount over \$1,000 should be shown as an in-kind contribution.

Loans from a financial institution that normally engages in the business of making loans is not considered a contribution if the loan is made in the regular course of business and on the same terms ordinarily available to the public. Candidates may make unlimited loans to his or her own committee from his or her personal funds or from joint funds of the candidate and the candidate's spouse. Such funds should be transferred to the candidate's campaign account and can be repaid by the candidate's campaign committee if the terms of the loan are documented in writing and signed and dated by all parties contemporaneously with the transfer.

Ms. Hall highlighted the requirements for contributions and expenditures reports as follows:

- Name, address, occupation and employer of any person other than a PAC making a contribution or contributions in excess of \$50 in the aggregate, date and amount of contribution whether monetary or in-kind;
- Name, date, and amount of contribution whether monetary or in-kind;
- Information on loans made to the committee or repaid to the committee;
- Name and address of any person or entity to whom an expenditure of more than \$200 in the aggregate; and
- Expenditures made by political consultants or other third parties on behalf of the candidate and with the candidate's knowledge must be reported as if the expenditures had been made directly by the campaign committee.

Ms. Hall said whenever a candidate committee makes an expenditure for the purposes of a communication through any internet advertising, or video, radio, television, cable or satellite broadcast, the communication shall state, either orally or in writing of sufficient size and contrast to be clearly readable by the recipient of the communication: "Authorized and paid for by NAME OF COMMITTEE." Whenever a candidate committee makes expenditure for the purposes of a communication through internet advertising or direct mail, magazine advertisement, newspaper advertisement or any other printed medium, the communication will have the same statement clearly readable.

Member Hilbert said the State Ethics Commission does not have enough personnel to enforce reporting violations and Ms. Hall agreed. She learned the Ethics Commission only has a Staff of six, which is not enough Staff to do everything that needs to be done for the entire State. Chairman Hardiman said citizens will want NEC to enforce these regulations, but the City will be at the mercy of what the State wants to do. Ms. Hall said all the City can do is forward complaints to the Ethics Commission for them to investigate. She said the City cannot take specific action on any violation or file charges.

Item 3. Miscellaneous Discussion.

Mr. Bobby Stevens, Post Office Box 6227, said he is a candidate for Ward Five and has been very careful about where he places his campaign signs so they are not illegal. He said campaign signs are supposed to have the name of the person, business, or organization who paid for the campaign sign printed on the sign, signs can be no larger than 20" by 30," and cannot be placed on highways. He said his opponent, Lynne Miller, does not have one legal sign in Norman. He asked what the City is going to do about Lynne Miller's illegal signs.

Chairman Hardiman said a Code Compliance Officer speaks to candidates during the orientation process about the do's and don'ts on campaign signs. He asked City Clerk Hall who is assigned to deal with signs in a site triangle or right-of-way and Ms. Hall said the enforcement authority for the City is the Code Compliance Division. She said once Mr. Stevens turned in a complaint to her office she asked the Code Compliance Division to pull any illegal signs at the locations reported. She said signs cannot be more than 20" by 30" when placed in front of a single family residence; however, signs can be larger if they are on private property and not in the right-of-way. Chairman Hardiman said he remembers the Code Enforcement Officer saying the 20" by 30" size being acceptable on the ground if placed on the inside of the sidewalk, but not the outside of the sidewalk which is the right-of-way.

Ms. Hall said campaign signs are not allowed along scenic highways and Highway 9 is designated as a scenic highway from I-35 to the eastern city limits and Code Enforcement Officers pulled campaign signs along that highway. She said business signs are an exception along scenic highways and although campaign signs are not specifically listed as an exception on scenic highways if this issue comes up in the future, the Legal Department would have to determine whether or not that is a free speech right and if first amendment rights trump the scenic highway regulations. Ms. Hall said all illegal signs were pulled the next day.

Ms. Hall said there is a provision in the new ethics rules regarding disclosure that basically states that when a campaign makes an expenditure for the purpose of communicating through printed material, the printed material must have the statement "authorized or paid for by" with the name of the committee; however, there is an exception for items where the print would be small and illegible such as bumper stickers, t-shirts, campaign buttons, etc. She said the rules are interpreted and enforced by the Ethics Commission at the State level, not by the City. She contacted the Ethics Commission's General Counsel, Mr. Geoff Long, and was told that yard signs are lumped into the exception category and disclosure language is not required. She said it is all about the intent and practicability of placing language on a sign that can be easily be seen and read while driving by. She said although there is no measurement on the size a sign has to be before disclosure language is required, billboards would qualify. Chairman Hardiman said if a sign did not comply with State Ethic Commission rules would Code Enforcement remove the sign and Ms. Hall said no, the City's enforcement officials can only regulate City ordinances. She said signs in the right-of-way can be removed by the City.

Miscellaneous Discussion, continued:

Chairman Hardiman said he is surprised this issue has not come up before and Ms. Hall said it has come up in the past, but it has always been regulated by the Ethics Commission and is not under the Norman Election Commission's purview.

Mr. Stevens said when he read the rules, it was his understanding that "paid for by" must be on the sign and his campaign signs do have that language plus the date of the election. He felt that should be the rule so that candidates cannot use the same signs every time they run for office.

Chairman Hardiman said a Senate Bill SB438 (SB438) is currently being considered affecting election commissions. SB438 was introduced by Senator John Sparks and Representative Emily Virgin. The Bill started out addressing campaign contribution limits for Municipal elections, after consideration by the House of Representatives, it now no longer addresses contribution limits. Currently, the Bill states if a Municipality wants to create an election ordinance, a commission to oversee elections, and an enforcement body they can basically step out of the State Ethics Commission oversight. He said if the Bill passes, he does not know if this commission would want to take that on and if they did he did not know if the City Council would want to take it on.

Co-Chairman Hilbert said change must be comprehensive, it cannot be a small change and Ms. Hall said that is correct. She said in December, Council had some opposition to deleting the City's local rules and adopted a resolution requesting the legislative delegation consider allowing that. Council asked for some deviation or waiver on contribution limits as well. The current Bill will allow municipalities to establish their own rules, procedures, reporting requirements, financial disclosure requirements, and enforcement requirements to be filed with the State Ethics Commission and to opt out of the statewide regulation, but municipalities would have to regulate those rules. She said the State Ethics Commission was not opposed to this, but they do not have enough staff to enforce other municipalities' rules and regulations.

Chairman Hardiman said the City would not be allowed to use their old rules and regulations because they are antiquated. Ms. Hall said the City's old rules and regulations did not have an enforcement provision or address financial disclosures, which SB438 states must be done. She said a new ordinance could look similar to the old rules and regulations, but would need to have more provisions in place. Chairman Hardiman said the State process could take up to a year and the Senate may not pass the Bill. He said if the Bill passes, the Norman Election Commission would discuss the Bill at that time.
