A RESOLUTION OF THE COUNCIL OF THE CITY OF NORMAN, OKLAHOMA, AUTHORIZING COMPROMISE SETTLEMENT OF THE CLAIM FILED BY HUGH CRAWFORD UNDER THE PROVISIONS OF THE WORKERS' COMPENSATION STATUTES OF THE STATE OF OKLAHOMA IN THE CASE OF HUGH CRAWFORD V. THE CITY OF NORMAN WORKERS' COMPENSATION CASE NO. WCC 2011-11741 Q; DIRECTING THE LEGAL DEPARTMENT TO THEN FILE SUCH SETTLEMENT AND ALL ATTENDANT COSTS IN THE WORKERS' COMPENSATION COURT, OKLAHOMA CITY, OKLAHOMA; AND AUTHORIZING AND DIRECTING THE FINANCE DIRECTOR TO SUBSEQUENTLY PURCHASE SUCH WORKERS' COMPENSATION COURT JUDGMENT FROM THE RISK MANAGEMENT INSURANCE FUND.

- §1. WHEREAS, HUGH CRAWFORD was a firefighter for the City of Norman Fire Department who alleged spine, neck, left arm, and left shoulder injury due to cumulative trauma; and
- §2. WHEREAS, the City of Norman has negotiated settlement for the claim of HUGH CRAWFORD against the City of Norman, under the Workers' Compensation Statutes for a total of \$99,200 (WCC 2011-11741 Q, 28% \$50,260 Neck (cervical spine), 29% \$52,055 Back (lumbar spine), \$1,500 continuing medical maintenance, \$2,000 disfigurement, and includes \$6,615 less TTD Overpayment to close out any future medical or pain maintenance) to be paid in a lump sum settlement to Mr. Crawford, and such settlement is believed to be fair and reasonable; and
- §3. WHEREAS, the City shall incur additional costs for the settlement for payment for WCC 2011-11741 Q (spine, neck, left arm, and left shoulder) to the Workers' Compensation Administration Fund in the amount of \$1,984; the Special Occupational Health and Safety Fund in the amount of \$744; and filing fees in the Workers' Compensation Court in the amount of \$140; and filing fees in the Cleveland County District Court in the amount of \$125.70; and
- §4. WHEREAS, the Risk Management Insurance Fund of the City of Norman has heretofore appropriated funds for the payment of Workers' Compensation settlements covering injuries to qualified persons employed by the City of Norman; and



- §5. WHEREAS, the judgment and award should be transmitted and certified to the Workers' Compensation Court, Oklahoma City, Oklahoma, which when filed will constitute judgment against the City of Norman, which it is entitled to purchase with funds out of the Risk Management Insurance Fund pursuant to Okla. Stat. tit. 85, § 301, Okla. Stat. tit. 51, § 159, and Okla. Stat. tit. 62, § 361, et seq.; and
- §6. WHEREAS, the City Council finds it will be in the best interest of the City if the funds of the Risk Management Insurance Fund are invested in said judgment; and
- NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NORMAN, OKLAHOMA:
- §7. That the Legal Department is authorized to enter into settlement with one HUGH CRAWFORD for not more than \$99,200 for any and all claims that he has or may have against the City of Norman under the Workers' Compensation Statutes for any and all injuries known or unknown which occurred while working for the City of Norman; and
- §8. That the Legal Department is directed to hereinafter file such settlement in the Workers' Compensation Court, Oklahoma City, Oklahoma, along with all attendant costs therefore, as provided by law; and
- §9. That the Finance Director is authorized and directed to purchase such judgments of the Workers' Compensation Court, Oklahoma City, Oklahoma, out of funds of the Risk Management Insurance Fund of the City of Norman.
