Know all men by these presents that RDNJ, LLC. DBA: A-Tech Paving, as PRINCIPAL, and International Fidelity Insurance Company, a corporation organized under the laws of the State of New Jersey, and authorized to reenact business in the State of Oklahoma, as Surety, are held and firmly bound unto the State of Oklahoma in the Sum of Two Hundred Eleven Thousand, Six Hundred Two Dollars and 90/100**** DOLLARS (\$ 211,602.90), for the payment of which sum PRINCIPAL and SURETY bind themselves, their heirs executors, administrators, successors and assigns jointly and severally.

WHEREAS, the condition of this obligation are such, that the Principal, being the lowest and best Bidder on the following PROJECT:

Otherwise this obligation shall remain in full force and effect. If debts are not paid within thirty (30) days after the same becomes due and payable, the person, firm, or corporation entitled thereto may sure and recover on this Bond, subject to the provisions of 60O.S. 1981 S2 for the amount so due and unpaid.

It is further expressly agreed and understood by the parties hereto that no changes or alterations in said CONTRACT and no deviations from the plan or mode of procedure herein fixed shall have the effect of releasing the SURETIES, or any of them from the obligation of this Bond.

It is further expressly agreed that the Principal’s obligations under this Bond include payment of not less than the prevailing hourly rate of wages as established by the Commissioner of Labor of the State of Oklahoma and by the Secretary of the U.S. Department of Labor or as determined by a court on appeal.


