Further, whereas Agency agrees, upon receipt of a portion of said funds, to provide for operational activities associated with the Community Development Housing Organization, Norman CHDO 2015, Inc.

For and in consideration of the activities agreed to be performed herein, by Agency, City agrees to distribute to Agency as its portion of the funds received, the total sum of \$14,000. Said funds to be distributed by City to Agency pursuant to the terms and conditions of Grant Number M-14-MC-40-0204 by and between the U.S. Department of Housing and Urban Development and the City for the funding period of July 1, 2014, through June 30, 2015.

As further consideration for the disbursement of said funds by City to Agency, Agency agrees to abide by all the terms and conditions of the HOME Investment Partnerships Program and the OMB Circular A-122 entitled Cost Principles for Non-Profit Organizations to use funds distributed pursuant to this contract to improve the quality of services to program participants. Particular attention should be paid to purchasing and record-keeping requirements.

It is further understood by and between the parties hereto that all the provisions of the HOME Investment Partnerships Program Contract described above are incorporated herein by reference and made a part of this contract and specifically that all provisions regarding modification, termination, and/or suspension of said Home Investment partnerships Program Contract are applicable hereto.

General Provisions -- Records & Reports:

Agency shall maintain financial records documenting actual expenditures related to HOME activities performed under this contract. Records must also be maintained by Agency documenting all activities required under this contract. These records shall be kept for a period of five (5) years after completion of this Contract.

Agency will submit copies of all transactions to the Community Development Division detailing all activities performed with the use of City of Norman HOME funds. Agency will make all required records available for inspection by the City of Norman Community Development Division for monitoring purposes.

Agency shall ensure recognition of the role of the grantor Agency in providing services through this contract. All activities, facilities and items utilized pursuant to this contract shall be prominently labeled as to funding source. In addition, Agency will include a reference to the support provided herein in all publications made possible with funds made available under this contract.

Program Income:

Although none is anticipated, any program income generated by Agency from the use of City of Norman HOME funds shall be recorded. Agency may retain program income and expend it only on those activities noted in this contract.

Uniform Administrative Requirement:

Agency shall carry out all activities in compliance with all Federal laws and regulations described in Sub-part & of 24 CFR Part 560 except 570.604. Agency does not assume responsibility of 24 CFR Part 52.

Suspension and Termination:

In accordance with 24 CFR 85.43, suspension or termination may occur if Agency materially fails to comply with any term of the award, and the award may be terminated for convenience in accordance with 24 CFR 85.44.

Reversion of Assets:

Upon expiration of this contract Agency shall transfer to the City of Norman any HOME funds on hand at the time of expiration and any accounts receivable attributable to the use of City of Norman HOME funds.

Payment:

Agency agrees to submit an invoice which reflects the direct costs under this Contract. The City will make payments from these invoices. Each invoice in excess of \$12,500 must be accompanied by a notarized affidavit provided by the City. The City will provide to Agency invoices to be used with payment requests.
