### To Whom It May Concern:

The purpose of this letter is to "Demand the Release of Easement" for the public utility easement and right-of-way for the public sanitary sewer line (the "Line") which was granted to the City of Norman, attached as Exhibit A and titled as "GRANT OF EASEMENT" (THE "Grant"), which was executed on February 24, 2009 by Barbara Ohsfeldt representing Community Christian School, Inc., an Oklahoma corporation ("Grantor"). This easement was granted upon and across the following real estate property and premises, situated in Cleveland County, State of Oklahoma, to wit:


A part of Lot 1, Block 1 And a part of Lot 2, Block 1 COMMUNITY CHRISTIAN ADDITION an addition to Norman, Oklahoma, which is a part of the SW/4, Section 2, T9N, R3W, I.M.

This Release of Easement is timely demanded pursuant to the terms of the Grant which provides:

If construction of the Line has not commenced within five years after the date of the Grant of Easement or if construction of the Line is not completed within one year after commencement of construction, upon the demand of the Grantor the City shall execute and record a release of this easement.

#### As of this date:

- 1. Commencement of the construction of the Line has never taken place.
- 2. Five years have passed since the Grant.
- 3. Six years have NOT passed since the grant.



Therefore, we hereby demand that the City of Norman execute and record a release of this easement.



### KNOW ALL MEN BY THESE PRESENTS

THAT COMMUNITY CHRISTIAN SCHOOL, INC, an Oklahoma corporation ("Grantor"), for and in consideration of the sum of One Dollar (\$1 00), receipt of which is hereby acknowledged, and for and upon other good and valuable consideration, do hereby grant, bargain, sell, and convey unto the City of Norman, a municipal corporation, a public utility easement and right-of-way over, across, and under the real estate and premises situated in Cleveland County, Oklahoma, and described on Exhibit "A" (the "Property"), with the right of ingress and egress to and from the Property, for the purpose of surveying, laying out, constructing, maintaining, replacing, and operating a public sanitary sewer line (the "Line")

To have and to hold the same unto the City, its successors and assigns forever

If construction of the Line has not commenced within five years after the date of this Grant of Easement or if construction of the Line is not completed within one year after commencement of construction, upon the demand of Grantor the City shall execute and record a release of this easement. Grantor's failure to demand this release by the earlier of (i) six years after the date of this Grant of Easement, or (ii) substantial completion of construction of the Line, shall constitute a waiver of the right to do so. If construction of the Line is commenced more than five years after the date of this Grant of Easement but before Grantor has demanded a release, then Grantor may not demand a release unless construction is not completed within one year after commencement.

Upon completion of construction of the Line and Grantor's demand, the City shall execute and record a release of all of the City's rights in the Property under this Grant of Easement except with respect to the portion of the Property with a width equal to the minimum width required by the applicable City of Norman Engineering Design Criteria then in effect plus ten feet on either side of the Line and except for the right of ingress and egress provided above


