### MISCELLANEOUS DISCUSSION

Social Media. Mr. Harold Heiple, 218 East Eufaula Avenue, said he had never been on social media and will never be on social media; but, late this afternoon he was told that there may be a war of words between two groups on social media and reported two members of his immediate family are in one of those groups. He said he is not here to advocate for either group and does not know or want to know the details. He said the two sisters who are longtime residents of Norman own a very small piece of property to be considered by Council in two weeks and asked Council to allow them to be free of any influence by the name of Heiple. He said for that reason, at 5:00 p.m., today, he called his clients and withdrew from the case immediately. He said the initial application has been changed in response to the protests at the Planning Commission and felt his actions will possibly allow them to get a fair hearing.

National Ice Cream Day. Mr. Rusty Rasmussen, Rusty's Frozen Custard, said Sunday, July 15th is National Ice Cream Day and his business, which is now located on the corner of East Main Street and Crawford Avenue, is celebrating that event with a Citywide celebration. He said there will be live music from 2:00 p.m. to 8:00 p.m. and Crawford Avenue will be closed to traffic. He said he had received all required permits from the City. He said the banana split eating contest will begin at 3:00 p.m. He displayed the winning trophy that had been with the winner, Councilmember Hickman, for the past two years and invited Councilmembers to come and dethrone the king. He said if anyone wants to use a surrogate, Councilmember Hickman's daughter beat his time last year which was one minute and five seconds. He said Mayor Miller is the guest judge this year and will be passing on the trophy to the winning Councilmember.

Councilmember Bierman said "Bring it On." She said she is taking that trophy home. She said she hopes all of Council shows up so she can beat all of them. She said it is a lot harder than one would think to gulp down a banana split.

Councilmember Scott said she also plans on going to the Banana Split Eating Contest and winning.

Councilmember Castleberry said he will be unable to attend but he is looking for a Ward Three competitor so Ward Three can bring home the trophy.

<u>Ethics Violation</u>. Mr. Casey Holcomb, Ward Four, asked if an ethics complaint could be read for the record right now in lieu of a formal written complaint. Mr. Jeff Bryant, City Attorney, said the preference would be to prepare a written complaint and turn it in to either the City Clerk or the City Attorney's Office.

<u>HVS Study of University North Park</u>. Mr. Evan Dunn, Citizen Solutions, 1400 Garfield Avenue, said he was glad the UNP budget appropriation did not pass. He said the City needs to figure out how to minimize fuel expenditures and wasteful spending.

Councilmember Clark said she is very frustrated about how the vote turned out to approve funding for the study because we are talking out of both sides of our mouth. She said Council asked for more information and postponed a vote and then Council gets a chance to get more information and turns it down. She said she will not have the information that she needs to make the best and most responsible decision on a vote for a community issue. She said it was Council's responsibility to get the information and the people that asked for more information, declined it. She said now the payment for the study will come out of the General Fund while City Staff has been asked to cut 11.4% of their budget and the City has a hiring freeze while Public Works has eight positions they need to fill. She said she hopes that Council can do a better job. She understood why Councilmembers Scott and Carter voted no because they were not on Council when the request for more information was made. She hopes Council can be more honest with one another so there will be productive conversations moving forward.

Miscellaneous Discussion, continued:

HVS Study of University North Park, continued. Councilmember Wilson said she had been very honest. She has pushed back on meetings that were private. She said the Study Session on July 17th will provide information on how to legally end a Tax Increment Finance District. She said she has respected the process all along the way but hopes she is teaching everyone how she wants to be treated as a Councilmember.

Councilmember Hickman said he voted against the study because of the process.

Councilmember Castleberry said he actually thought this was a very good meeting. He said each Councilmember showed their passion and that we can disagree with each other civilly. He said everyone had their reasons for either voting yes or no and he does not necessarily agree, but it is part of the process. He never had a problem with the meetings and if he thought there was a walking quorum, he would have walked out of the meeting. He said he was never asked how he was going to vote. He said these types of meetings were done during Stormwater Utility discussions and other items. He said these types of meetings are productive, especially when there are newer councilmembers. He said Council has a lot of different perspectives because they are a diverse group and talking with them in a small group teaches everyone a lot.

Councilmember Bierman said the emphasis should be on encouraging and generating public trust by displaying as much transparency and openness as possible. She said there is a trust deficit in this city and it is something that can only be addressed by working at it.

Mayor Miller said this past year she has learned so much about the economics and needs of our city. She said several months ago Council approved a Center City TIF, which was an economic piece to pull Campus Corner and Downtown together. She said Council was looking at a new University North Park TIF as an economic opportunity and were planning on looking at a strategic economic plan and the Kimley Horn Parking Project to help them make a decision. She said the HVS study would have answered some important economic questions not only for the north part but also the south part of the TIF.

<u>Griffin Park</u>. Mr. Scott Martin, Norman Chamber of Commerce, said his 11 year old son asked him to say thanks because he plays baseball and knows the City is closer to getting things worked out for the Griffin Park property to allow the baseball program to be moved to Reaves Park.

<u>Thanks Again</u>. Councilmember Scott said this was Councilmember Carter and her first official Council meeting and it had been surprising and fun.

Councilmember Holman welcomed both of them to Council. He said they got a little bit of a taste of what Council will be dealing with moving forward. He thinks this is a good group and can handle it.

Councilmember Hickman welcomed the new Councilmembers and said he was pleased to have them up at the dais and is looking forward to serving with them.

<u>Ward 8 Meeting</u>. Councilmember Scott said there would be a Ward 8 Meeting on Sunday, July 29th at a place to be determined. She said anyone watching from Ward 8 tonight, she was open for suggestions.

State Question 788. Councilmember Holman said after the new rules were passed today by the Oklahoma Department of Health regarding medical marijuana, he encouraged Council to consider a resolution in the next few weeks encouraging the State Legislature to honor the will of the voters who approved State Question 788. He said this State Question passed by a 71.5% vote in Norman and every single voting precinct in Norman approved it. He said Ward 7 had almost 3,000 voting in favor which was really eye opening. He said there are a lot of questions about the state law and it is not known what the city will regulate in the future. He said as the bill is written, the City will not receive any taxes from it but the City could be tasked with enforcing it. He said he felt it should be discussed in Council Retreat.

Miscellaneous Discussion, continued:

<u>State Question 788, continued.</u> Councilmember Hickman said he agreed with Councilmember Holman. He requested that this item be added to the next Community Planning and Transportation Agenda. He said it had already been on the agenda before it was passed and had been very informative and helpful. Now that it has passed, there should be a follow up discussion to see what role the City will play in the process.

<u>City Golf Tournament</u>. Councilmember Castleberry said no Councilmember showed up to challenge him at the City of Norman 4th of July Golf Tournament. He said the Westwood Invitational is a Statewide Golf Tournament that is a three day tournament and one of the only 54-hole golf tournaments in the state. He said it is very competitive and the tournament record was tied this year.

Norman Animal Welfare. Councilmember Bierman said Norman Animal Welfare does a fantastic job taking care of the animals. She said Staff and volunteers work incredibly hard. She said the Animal Welfare Center is waiving adoption fees through July 14th because there are a lot of animals that need homes. She said if anyone needs a cat or dog, please go and visit the Animal Welfare Center. All animals come after being checked by a Veterinarian, Spay/Neutered, and Micro-Chipped.

<u>Stormwater Open Houses</u>. Mayor Miller thanked the Stormwater Citizen's Committee members for holding three Stormwater Open Houses. She said Amanda Nairn, Co-Chair of the Committee has attended all of them along with City Staff including Carrie Evenson, Stormwater Program Manager. She said the meetings had been very positive and a lot of good questions have been asked.

### **CITY MANAGER'S REPORT**

<u>July Sales Tax Collections</u>. July Sales Tax revenue was \$4,753,008 which is up \$133,969 or +2.90% from July 2017.

**NORMAN FORWARD Westwood Aquatic Center**. Total attendance for the new Westwood Aquatic Center as of July 9th is 64,887. This is a 90% increase from 2016's total attendance of 34,100. There has been an increase in the water walkers program and toddlers program and the number of people taking swim lessons has doubled.

<u>12th Avenue Recreation Center</u>. New playground equipment is being installed at 12th Avenue Recreation Center with anticipated completion in early August. This project is being funded through Room Tax.

#

<u>Emergency Communication System Update</u>. This Public Safety Sales Tax Project is very important to our first responders and public safety officials. All six communication tower site locations have been secured and all of the tower construction has been completed and is awaiting equipment install. Tower equipment installation will be in the upcoming months. The switch over to the new radio system is anticipated to take place later this year.

**Norman Fire Department**. The new squad truck paid for with Public Safety Sales Tax dollars is being manufactured in Wisconsin to be housed at Fire Station No. 7. This truck replaces a piece of equipment that has reached the end of its service life. This provides standard fire protection in its district and rescue support for other fire crews and residents. The squad truck will be in operation later this year.

<u>Stormwater Citizen Committee Open Houses</u>. The Stormwater Citizen Committee has hosted a series of open houses to share information about a new stormwater proposal, answer questions, and gather feedback from residents. Open Houses were held on June 13, June 30, and July 9. There is an Open House scheduled on Wednesday, July 25th at Norman Public Library East, 3051 Alameda Street, from 3:30-5:30 p.m. Additional open houses possibly will be scheduled in the upcoming weeks.
