# MISCELLANEOUS DISCUSSION

<u>Storm Water Control</u>. Mr. Harold Heiple, 218 East Eufaula Avenue, said \$3,000,000 is being spent each year out of the General Fund for storm water control and the business community has supported a storm water utility for nine years. He was told a storm water fee of \$3,000,000 will replace what is being spent each year out of the General Fund; however, at the recent study session, Mr. Shawn O'Leary, Director of Public Works, said the funding needed for storm water control is \$4,300,000. He said an option was presented that will generate \$4,800,000. He said a 2017 Budget was presented this evening that showed a budget for storm water control to be \$8,200,000. He asked for clarification and was it the intent of Council to continue to spend \$3,000,000 out of the General Fund for storm water control regardless of what happens when there is an election for a Storm Water Utility.

Councilmember Holman said City Council has continued to delay action on the Storm Water Utility and now there are federal mandates that have to be met beginning this year. He said his intention while he is on Council is to fund as many storm water items as possible. He said he would like to use the funding from the Stormwater Utility to give relief to the General Fund but at the same time, there are a lot of obligations to fulfill and the City will need as much funding as they can get to address all of those needs. Miscellaneous Discussion, continued:

<u>Report from Raftelis Consulting</u>. Steve Ellis, 633 Reed Avenue, said the City of Norman is still withholding documents he requested prepared by Raftelis Consulting that have to do with the cost of development in Norman. He said the Open Records Act requires disclosure of all records in possession by the City unless they are specifically required by law to be kept confidential. He said when refusing the make the documents available for inspection, the City cited a confidentiality exemption that was irrelevant. He was directed by the City Attorney's Office to Section 24.89 which reads "a public official may keep confidential his or her personal notes and personally created materials prepared as an aid to memory". He said the Raftelis records are clearly not the personal notes and personally created materials of any city official but numbers and analyses prepared by a third party. He said the contract specifically says all documents prepared by Raftelis pursuant to the agreement are the property of the Norman Utilities Authority.

Councilmember Holman said he didn't think the way this was being handled made the City look very good.

<u>Cedar Lane Road</u>. Mr. Bobby Stevens, 4115 East Cedar Lane Road, said Item 8 was a first reading ordinance rezoning 762 acres in the area of Cedar Lane Road. He said Item 20 on the agenda this evening was approved to revise the current land use plan but changes are made to it all the time. He said Cedar Lane Road should have been completely widened and improved before Wal-Mart was allowed to build. He said a fire station is also needed in that area.

<u>Highway 9</u>. Mr. Bobby Stevens, 4115 East Cedar Lane Road, said there were four fatalities last night on Highway 9. He said this is a State Highway and it is being widening right in front of a nice addition, but nothing is being done east of that area.

<u>Senior Citizens Center</u>. Mr. Bobby Stevens, 4115 East Cedar Lane Road, expressed concerns about rushing to get the numbers for the Senior Citizens Center and feels it is misleading.

<u>Mayoral and City Council Election</u>. Mr. Bobby Stevens, 4115 East Cedar Lane Road, said he had been coming to Council Meetings for several years expressing his personal opinions. He said if he was Mayor he would have to put his opinions aside and have to deal with what the people wanted. He said he is not owned by the builders or the University of Oklahoma and takes contributions from no one. His campaign is run with his own money.

Councilmember Lang asked everyone to please vote on Tuesday, April 5th.

Councilmember Holman announced to Ward Seven voters that there are seven propositions asking for amendments to the City Charter that will be on the ballot. He said there is also a question on the ballot to approve bonds for road improvements. He said the Street Bond election had been approved in 2005 and 2010 and this is a continuance of those bonds. He said with approval of the Street Bond issue, there are 11 neighborhood streets in Ward 7 to be repaired or replaced and he encouraged residents to approve this.

Item 20, Comprehensive Plan. Councilmember Holman said he supported approval of this item tonight and there are a lot of examples in Norman of development that had occurred with no plan in place which had created issues, for example, two intersections by Sooner Fashion Mall that are very close together as a result of not having a comprehensive plan in place. He said when the 2025 Plan was adopted, it was not anticipated there would be high density residential or a demand for taller buildings. He said the plan also anticipated more industrial which has not happened. He said a lot has changed in 12 years and he agrees with the Planning Director that Norman is not a small town anymore, but a small city with growing pains. He said he sees the City continuing to grow because there are good schools and services and Norman is a nice place to live. He voiced concerns about the budget which is why he voted against this item this evening even though he feels the Comprehensive Plan study is necessary. Miscellaneous Discussion, continued:

<u>Ward Three Meeting</u>. Councilmember Castleberry announced a Ward Three Meeting would be held Wednesday, March 30th at 6:00 p.m. at the West Side Library to discuss the election, charter amendments, storm water, and Ward Three issues. He said Mayoral Candidates had been invited to attend. He said a map would be provided showing the bond projects in Ward Three included in the Street Bond Election.

#### CITY MANAGER'S REPORT

**Spring Cleanup in April**. Sanitation is providing free household clean up each Saturday in April. The first pickup begins April 2nd for those with Monday polycart service, April 9th for Tuesday customers; April 16th for Wednesday customers; April 23rd for Thursday customers; and April 30th for Friday customers. Additional information is available on our website. There is no additional charge or fee for this service. It is really important to keep our community clean and attractive. Picking up waste that some people store in their back yards helps control mosquitos and rodents.

<u>Search for New Fire Chief.</u> Applications have been received for the position of Fire Chief and interviews will be conducted with selected finalists by using an internal management panel and an external panel which will include Oklahoma Fire Chiefs and Norman stakeholders.

<u>Police Body Cameras</u>. Council previously approved the purchase of body cameras for Police Officers with Public Safety Sales Tax funds. The project had to be rebid due to issues with the vendor that had been selected. Proposals from new vendors are being evaluated and this item will be brought back to City Council to approve a new contract. Part of the implementation will include beta testing, officer training, and community education regarding our policy, how the cameras operate, and the benefits to the public.

<u>Saxon Community Park Fitness Trail</u> Bid were advertised for construction a 10 foot wide concrete fitness trail at Saxon Community Park which will extend 1/3rd mile. Saxon Community Park is located on East Highway 9 east of 48th Avenue S.E. The trail will be located south of the main park road and parking area. Funding for the trail was provided by a Recreational Trails Grant and Park Land development funds.

<u>Lindsey Street and I-35 Projects</u>. The existing bridge on West Lindsey over Interstate 35 will be demolished by the Oklahoma Department of Transportation in mid-May. There will be detours on Highway 9 and Main Street. The Highway 9 East Interchange at I-35 will be substantially complete with all ramps open mid-May.

<u>Westwood Family Aquatic Center</u>. Public meetings for the Westwood Family Aquatic Center will be held Wednesday, March 30th, and Thursday, March 31st, at 6:30 p.m. at City Hall. In order to reach out to the community for information about people's desires for different types of features they would like to see, a survey was sent out to email lists from local groups such as youth sports and associations and an electronic survey was sent out via the website and Facebook. The results will provide information about how to design the park.

<u>Senior Center Improvements</u>. The renovation project at the Senior Center has been completed and Seniors were welcomed back Monday, March 21st. There are new finishes on walls, ceilings, and floors. There has also been a renovation of the kiln room with a new concrete floor finish.
