Ms. Marsha McDaris, 448 College Avenue, said she was a property owner in the area that will be impacted by the Center City Form Based Code (CCFBC) which was adopted on First Reading this evening. She said she sent in a protest letter but it was not included in the backup material and said she will be glad to resubmit the letter, if needed. She said she attended the first Center City meeting and got the impression that this area of town does not have the infrastructure in place to support further development, especially multi-family development. She said what is missing in this area are affordable single-family homes and there is no emphasis at all on single family housing. She said in the past two years, two neighborhoods have downzoned from R-3 to R-1 which speaks loudly about what is needed in this area. She said one good thing about the CCFBC is that the public is made aware before any demolition or construction begins. She said she feels the CCFBC gives too much power to builders and developers.

NORMAN FORWARD.

<u>East Branch Library</u>: Site grading and earth work are 90% completed. Installation of the sewer line is underway. Construction of the building pad has made substantial progress and during the next three weeks there will be installation of some of the utilities under the pad.

<u>Westwood Family Aquatic Center</u>. Construction works have been setting the forms for the three meter dive tower, lazy river walls, and lap pool shell construction.

#

<u>Lindsey Street Bond Project</u>. Lindsey Street is the Gateway to the University of Oklahoma and serves as one of the commercial corridors. Before the project started, Lindsey Street was the number one traffic congested area in the entire Oklahoma City metro area. This area has traffic accident rates about three times the national average for similar classified roadways. Lindsey Street and McGee Avenue are known as "Lake McGee" which is ranked the number one stormwater drainage issue. This project will accomplish these chronic problems that have plagued the community for a number of years by improving drainage and access and adding Streetscaping. The project is 65% complete. Major infrastructure that has been completed such as the Lindsey Street Bridge over Imhoff Creek; an 8 foot by 7 foot drainage structure from McGee Drive to 24th Avenue S.W. and the other drainage structure from Wylie Road to Imhoff Creek.
