

AN ORDINANCE OF THE COUNCIL OF THE CITY OF NORMAN, OKLAHOMA AMENDING ARTICLE II, CHAPTER 5 OF THE CODE OF THE CITY OF NORMAN BY DELETING SECTION 5-206 WHICH DESIGNATES THE FIRE LIMIT DISTRICT; AND PROVIDING FOR THE SEVERABILITY THEREOF.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORMAN, OKLAHOMA:

- § 1. That Section 5-206 of Article II of Chapter 5 of the Code of the City of Norman shall be deleted as follows:

Sec. 5-206. ~~Fire limits.~~ Reserved.

~~The fire limit district includes all property not zoned residential within the areas bounded by:~~

- ~~(1) — Beginning at the intersection of Alameda Street and Ponca Avenue, north along Ponca Avenue to Acres Street, west along Acres Street to Daws Street, west along Daws Street to Webster Avenue, south along Webster Avenue to Tonhawa Street, west along Tonhawa Street to Pickard Avenue, north along Pickard Avenue to Kansas Street, west along Kansas Street to Berry Road, south along Berry Road to Barbour Street, along Barbour Street to Foreman Circle, along Foreman Circle to Foreman Avenue, along Foreman Avenue to Main Street, east along Main Street to Gatewood Drive, south along Gatewood Drive to a point due west of Garver Street to Pickard Avenue, south on Pickard Avenue to the centerline of Comanche Street, then due east of Lahoma Avenue, north along Lahoma to the intersection with Comanche Street, along Comanche Street to Santa Fe Avenue, south on Santa Fe Avenue to Symmes Street, east along Symmes Street to Peters Avenue, south along Peters Avenue to Alameda Street, then east along Alameda Street to the point of beginning.~~
- ~~(2) — Beginning at the intersection of Boyd Street and DeBarr Avenue, then north along DeBarr Avenue to Duffy Street, west along Duffy Street to Asp Avenue, northerly along Asp Avenue to Apache Street, west along Apache Street to University Boulevard, south along University Boulevard to Boyd Street, east along Boyd Street to the point of beginning.~~

- § 2. Severability. If any section, subsection, sentence, clause, phrase, or portion of this ordinance is, for any reason, held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision,

and such holding shall not affect the validity of the remaining portions of this ordinance, except that the effective date provision shall not be severable from the operative provisions of the ordinance.
