## AMENDMENT NO. 1 TO CONTRACT NO. <u>K-1516-78</u> AGREEMENT FOR PROFESSIONAL SERVICES BETWEEN CITY OF NORMAN AND ENGINEER

  - b) Prepare Median Closing Plan and incorporate into 24<sup>th</sup> Avenue and Radius Way Intersection Improvement Plans.
  - c) Revise and update the Erosion Control Plan to include the Median Closing.
  - d) Update Title Sheet to include additional plan sheets.
  - e) Update and revise the material quantities for construction.

OWNER and ENGINEER in consideration of the mutual covenants herein agree to the following in respect to the performance of Professional Engineering Services and the payment for those services by OWNER as set for below for the above described additional scope of work.

- 2. For additional services described herein, the CONSULTANT shall be paid a lump sum fee of \$4,500.00.
  - 2.1. All other requirements of the ENGINEER included in the Original Contract shall remain in effect for the purposes of this agreement.

This Amendment No. 1 is subject to all terms, covenants, and conditions not inconsistent herewith contained in the Original Contract No. <u>K-1516-78</u> dated <u>November 24, 2015</u> which terms, covenants, and conditions are hereby reaffirmed and ratified.
