Ordinance O-2021-16

AN ORDINANCE OF THE COUNCIL OF THE CITY OF NORMAN, OKLAHOMA, DETACHING PROPERTY WITHIN THE CORPORATE LIMITS OF THE CITY OF NORMAN, OKLAHOMA, AND DESIGNATING THE AREAS OR TRACTS INCLUDED IN SUCH DETACHMENTS; REPEALING ALL OTHER ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH; AND PROVIDING FOR THE SEVERABILITY THEREOF (SHELLEY ACRES TRACTS 1 AND 2 AND THAT PORTION OF PROPERTY ZONED I-2 HEAVY INDUSTRIAL LYING SOUTH OF BETHEL ROAD, NORTH OF INDIAN HILLS ROAD AND ALONG THE WEST EDGE OF RAILROAD RIGHT-OF-WAY).

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORMAN, OKLAHOMA:

§ 1. That the Corporate Limits of the City of Norman, Oklahoma, shall be and the same is hereby detached to exclude the following described land situated in Cleveland County, Norman, Oklahoma, to wit:

All that part of the North Half (N/2) of Section Thirty-Five (35), Township Ten (10) North, Range Three (3) West of the Indian Meridian, Cleveland County, Oklahoma, currently within the limits of the City of Norman, lying between the Little River and the west edge of the railroad Right-of-Way, being further described as follows:

Tracts 1 & 2 of the Rural Certificate of Survey named Shelley Acres recorded at Bk. 4154, Pg. 28 in the records of the Cleveland County Clerk AND a tract of land described in the Warranty Deed recorded at Bk. 2381, Pg. 732 in the records of the Cleveland County Clerk, being more particularly described as follows:
