He said the purpose of COMMSTAR is to thank civic groups for supporting Tinker Air Force Base but citizens should thank Tinker Air Force Base because the pilots who fly these refueling tankers are reservists, not career military personnel, and they fly to the Middle East to refuel tactical aircraft.

<u>Christmas Parade</u>. Councilmember Gallagher said the Christmas Parade was a lot of fun. He said he wished more of the commercial vehicles in the procession had been decorated. He said in the past, the Christmas Parade was heavily festooned with decorations and he wished that would continue. He said it was a very enjoyable parade with lots of children in attendance.

Grants for the Police Department. Councilmember Gallagher said there were two grants remaining that had not been mentioned in Items 25 and 26. He asked if this grant funding had been used to purchase communication system software. Mr. Steve Lewis, City Manager, said the funding had been used but asked Mr. Anthony Francisco, Director of Finance, for additional details. Mr. Francisco said the funding was used in previous Council action.

<u>Traffic Accidents in Norman</u>. Councilmember Kovach said Council discussed traffic accidents occurring in Norman at the last meeting. He said at that time he did not realize that one of the fatalities was a friend of his. He said you never know when you are not going to have a chance to say something to someone again. He urged citizens to slow down and take the time to talk and listen to someone. He said he appreciates the efforts that Council and the City Manager have made on addressing issues on Highway 9 and other traffic related problems.

Item 28, Miscellaneous Discussion, continued:

<u>Budget Discussion</u>. Councilmember Castleberry thanked Mr. Anthony Francisco, Director of Finance, for answering his questions this past week about the budget process. He said he had emailed and called Mr. Francisco several times and appreciated his professionalism and quick response.
