### **HISTORY:**

- 1. October 12, 1965. City Council adopted Ordinance No. 1823 placing a portion of this property in R-1, Single Family Dwelling District.
- 2. June 28, 1977. City Council approved the final plat for Smoking Oaks South Addition.
- 3. <u>December 8 1977</u>. The final plat for Smoking Oaks South Addition was filed of record with the Cleveland County Clerk.
- 4. <u>April 10, 1984.</u> City Council adopted Ordinance No. O-8384-102 placing a portion of the property in PL, Private Park land designation.
- 5. <u>July 14, 1994.</u> Planning Commission, on a vote of 8-0-1, approved Short Form Plat No. SFP-9495-1, Lot 7 and part of Lot 8, Block 1, Smoking Oaks South Addition.
- 6. <u>July 15, 1994</u>. Short Form Plat No. SFP-9495-1, Lot 7 and part of Lot 8, Block 1, Smoking Oaks South Addition was filed of record with the Cleveland County Clerk.

## **IMPROVEMENT PROGRAM:**

- 1. Fire Hydrants. Fire hydrants are existing.
- 2. Sanitary Sewers. Sanitary sewer mains are existing.
- 3. Sidewalks are existing.

### **PUBLIC DEDICATIONS:**

- 1. Easements. Easements were dedicated with the final plat for Smoking Oaks South Addition.
- 2 <u>Rights-of-Way</u>. Street right-of-way was dedicated with the final plat for Smoking Oaks South Addition.
- **SUPPLEMENTAL MATERIAL**: Copies of a location map and short form plat are included in the Agenda Book.
- STAFF COMMENTS AND RECOMMENDATION. The owner has purchased an additional lot, Lot 6, Block 1, Smoking Oaks South Addition and intends to remove the existing structure on the lot.
