SUMMARY OF ACTIVITIES

JANUARY

Jackie Farley was re-elected as Chair and Heather Perry was re-elected as Vice-Chair of the Board of Parks Commissioners.

FEBRUARY

An appreciation plaque was also presented to Hank Enterline for his outstanding support service for Rotary Park. The Norman Amateur Softball Foundation presented their annual report to the board.
