ANNUAL TEAM BUILDING AND GOAL PLANNING SESSION REGARDING CITY COUNCIL POLICY AGENDA FOR FYE 2020.

Mayor Clark welcomed everyone and said she was looking forward to working with Council to establish goals and objectives for the coming year. She said with new councilmembers and a new mayor this year she asked Ms. Brenda Hall, City Clerk, to provide an outline of the Mayor's duties and Council roles and responsibilities.

Ms. Hall provided an overview of Mayoral duties and meeting decorum/rules of debate as outlined in Chapter 2 of the Code of Ordinances as well as parliamentary procedures as outlined in Robert's Rules of Order. Councilmembers also reviewed the House Rules adopted by Resolution R-0506-38 currently hanging in the Council Chambers. Ms. Hall also provided information regarding the agenda process and professional development opportunities including the use of campaign funds.

Public Works Projects

Mr. Shawn O'Leary, Director of Public Works, provided an update on the 36th Avenue NW and Indian Hills Road improvement plans. He also provided information on the items to be included on Council's July 30th Special Session regarding the bus transit system.

Social Media

Councilmembers discussed their involvement on social media sites and Mr. Rick Knighton, Assistant City Attorney, provided an overview of social media guidelines to follow.

Mission and Values Statement

Councilmembers participated in a team building exercise to create a values and mission statement reflective of their goals and objectives. The result of the exercise was:

Transit Election

Councilmembers discussed calling a special election for the renewal of a portion of the one-eighth of one percent (1/8%) sales tax currently dedicated to Cleveland County for the purposes of providing public transit. Council reviewed draft ballot language and provided direction for staff to move forward in preparing the necessary ordinances calling for the election to be reviewed at their Council Conference on August 13th.

Councilmembers reviewed last year's goals and discussed what to include and/or update for priority moving forward. Councilmembers also participated in a goal setting exercise for FYE 2020 to add to carry-over goals from the previous year.
