KNOW ALL MEN BY THESE PRESENTS:

That in consideration of the sum of One Dollar (\$1.00), receipt of which is hereby acknowledged, and for and upon other good and valuable considerations, that Charles Harmon, does hereby grant, bargain, sell and convey unto the **City Of Norman**, a municipal corporation, a **public roadway, drainage and utility easement**, over, across and under the following described real estate and premises situated in Cleveland County, Oklahoma, to wit:

(17' Additional R/W)

A strip of land in the West Half of the Northeast Quarter (W1/2-NE1/4) of Section Twenty-four (24), Township Nine (9) North, Range Two (2) West of the Indian Meridian, Cleveland County, Oklahoma, written by Timothy G. Pollard, PLS 1474 dated August 25, 2020 using an Arbitrary bearing of N89°49'20"E between existing monuments on the North line of said NE1/4 as a Basis of Bearing, said tract further described as:

COMMENCING at the Northwest Corner of said W1/2-NE1/4;

Thence N89°49'20"E, on the North line of said W1/2-NE1/4, for a distance of 330.00 feet;

Thence S00°22'58"E and parallel to the West line of said W1/2-NE1/4 for a distance of 33.00 feet to the **POINT OF BEGINNING**;

Thence N89°49'20"E for a distance of 990.93 feet to the East line of said W1/2-NE1/4;

Thence S00°10'52"E, on the East line of said W1/2-NE1/4, for a distance of 17.00 feet;

Thence S89°49'20"W for a distance of 990.87 feet;

Thence N00°22'58"W and parallel to the West line of said W1/2-NE1/4 for a distance of 17.00 feet to the **POINT OF BEGINNING**, containing 0.3867 acres more or less subject to easements and rights-of-way of record.

With the right of ingress and egress to and from the same, for the purpose of surveying, laying out, constructing, maintaining and operating the facilities indicated below:

Public Roadway, Drainage and Utility Easement

To have and to hold the same unto said City, it's successors and assigns forever.

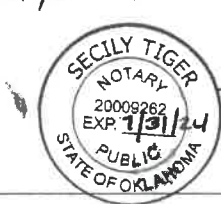
