THENCE North 00°15'03" West a distance of 5.04 feet to the POINT OF BEGINNING;

THENCE continuing North 00°15'03" West a distance of 5.03 feet;

THENCE North 89°47'15" East a distance of 52.72 feet;

THENCE South 00°15'06" East a distance of 5.00 feet;

Thence South 89°44'59" West a distance of 52.72 feet to the POINT OF BEGINNING.
