MISCELLANEOUS DISCUSSION

Website Information. Mr. Mark Campbell, 517 North University Boulevard, said the City website does not have accurate information. He said in the past the agendas were linked to the Boards and Commissions meeting calendar and all you had to do was click on that date and you were given the agenda. He said he did not think this was transparency.

Ms. Joy Hampton, The Norman Transcript, 215 East Comanche Street, said she had asked Staff about the agendas that used to link from the calendar and was told that because of some computer glitches, it had been stopped. She said it is hard for a citizen to access City Council agenda. She asked if this could be addressed in the near future if at all possible.

Mr. Bill Hickman, 517 Macy Street, said the Center City Visioning Committee meeting agenda had not been on the City Calendar on the Website and he could not access the backup materials for the oil and gas ordinance.

Councilmember Holman said one improvement that would assist the citizens is a City of Norman App. He said the website can be difficult to navigate.

Miscellaneous Discussion, continued:

Website Information, continued. Councilmember Castleberry said he and Councilmember Heiple had discussed during City Council Business and Community Affairs meetings, the possibility of creating a City App. He said he finds it frustrating sometimes to try to find an agenda. He suggested if a person has problems, please contact their Council person.

*

Norman Forward. Mr. Mark Campbell, 517 North University Boulevard, asked what the City of Norman's relationship was with Norman Forward.Com, and the Norman Forward Facebook Page. He said they are displaying erroneous information.

Mr. Will Decker, 311 South Webster Avenue, said Council had to determine if it would be feasible to place the Senior Center in the library building at 325 South Webster Avenue. He asked Councilmembers to let him know what telephone number they could be reached at for citizens who wish to contact them on the issue.

Mr. Bobby Stevens, Post Office Box 6226, said the Senior Citizens Center should come first in this proposal.

Mr. Roger Gallagher, 1522 East Boyd Street, voiced concerns about the partnership with the YMCA for the Aquatic Facility because if public money is involved, three estimates are required for construction of any buildings. He said if a lower bid than what the YMCA has bid, that could be an expensive problem.

Mr. Bill Hickman, 517 Macy Street, asked Council to consider putting funding for the Center City Visioning Project in Norman Forward.

Councilmember Castleberry said all projects will be bid out and the best bid will win. He said the YMCA is certainly qualified but that does not mean they will get the project. He said it will be the same case for the Soccer Facility, Norman Youth Soccer Association is qualified but they might not get the bid.

*

Animal Shelter. Ms. Rebecca Bean, Animal Shelter Oversight Committee member, 1116 Caddell Lane, said she was concerned at the rate of speed with which the proposed changes to animal related ordinances are taking place. She said last month local veterinarians and members of rescues were invited to two meetings to discuss the changes; however, only four veterinarians and three rescue groups were able to attend. She said they were told that the current plan is to bring something forward to City Council for approval in September. She said this means that the Animal Shelter Oversight Committee will be asked to approve the most recent draft on August 3rd which does not give the committee adequate time to review the language of the document which is over 30 pages. She said she, along with four veterinarians, requested that the committee be given time to comb through the details at the August meeting, suggest final changes, and approve a final draft at the September Oversight Committee meeting at the earliest. She asked Councilmembers to contact her if they have questions.

Ms. Darcie Woodson, 4409 Trophy Drive, said she received the updated Animal Shelter volunteer numbers for the month of June and was pleased the numbers had increased. She said there were only 9 1/2 hours for dog walking for the entire month. She said staff is great but overworked and do not have time for dog walking. She said citizens expect dogs to be walked on a daily basis and volunteers could be used to do this. She read excerpts from past Animal Shelter Oversight Committee minutes regarding a request for volunteers. She said the classes are offered only during normal working hours and if a person has a job, they cannot take off. She said the shelter had an active volunteer program and most of those volunteers left to go to other groups and/or shelters where they have done great. She said it is a known issue that the shelter had problems maintaining volunteers. She said she hoped the City will work harder to recruit and keep volunteers because the animals deserve better and the citizens overwhelmingly voted to build a new center.

Mr. Bill Hickman, 517 Macy Street, thanked the Police Department and the City Attorney's Office for working with citizens regarding the changes to the Animal Shelter ordinance. He asked Council to look at the resolution adopted in May, 2003, adopted by the City Council, regarding the Animal Shelter. He said the resolution says it is Council's intent by building the pet adoption facility to adopt a new policy change to include adoption, education, citizen involvement, and spay/neutering rather than euthanasia shall the preferred methods to address unclaimed and unwanted animals. He asked Council to strongly consider adopting a new resolution showing commitment and support to those claims.

*

Five Minute Limit. Mr. Bobby Stevens, Post Office Box 6226, said there did not used to have a five minute limit on discussion. He said Council encourages people to come to the meeting and voice their opinion and limited time was a form of silencing them.

*

Miscellaneous Discussion, continued:

Oil and Gas Ordinance. Mr. Bobby Stevens, Post Office Box 6226, said he wondered how many people had died as a result of an oil well in the city limits of Norman.

Mr. Steve Ellis, 633 Reed Avenue, said the City should not close the book on the oil and gas ordinance because the City does not have a very good legal argument regarding setbacks which are calibrated to address public needs such as health and safety.

Mr. Bill Hickman, 517 Macy Street, thanked Council for their hard work on revision of this ordinance. He offered assistance on additional oil and gas review.

Ms. Mary Francis, 850C Cardinal Creek Condos, asked what would happen if water testing reveals contamination from dangerous chemicals. She asked if regulations are already in place that require further testing. She said she really appreciated the information provided.

*

Ambulances. Mr. Bobby Stevens, Post Office Box 6226, said there are eighteen ambulances in Norman and the Norman Regional Health Systems plans to buy two more ambulances to take care of Moore. He said there is no ambulance station in his ward and felt it was unacceptable.

*

Thanks to City Staff. Ms. Joy Hampton, The Norman Transcript, 215 East Comanche Street, commended City Staff for always being available to answer questions.

*

Additional Code Enforcement Staff Needed. Mr. Roger Gallagher, 1522 East Boyd Street, suggested an employee be hired to work in Code Enforcement on weekends especially after all the recent rainfall. He said recently someone moved into the neighborhood and when the yard was finally mowed, all of the grass had been blown in the street. He said it took several days for the cars and wind to blow it back against the curb. He said this person could also address problems with people watering on the wrong day.

*

Vehicle Inspections. Mr. Roger Gallagher, 1522 East Boyd Street, said he knew having regular inspections of vehicles had been eliminated by State statute but he wished the City could do something because many older models have very noxious fumes that are dangerous.

*

Bishop Creek. Mr. Bill Hickman, 517 Macy Street, thanked City Staff for the work that had been on Bishop Creek to allow the vegetation to grow around the creek.

*

Shop Norman. Councilmember Castleberry said "Shop Norman."

*

Thanks to Audience. Councilmember Williams thanked all those who stayed this evening for the whole meeting. He said it is easy to talk about what you want to talk about and then just leave, he appreciated those committed people who were still here.

Councilmember Miller said she agreed.

Mayor Rosenthal commended Mr. Luke Albert for staying the whole evening. She said it has been her privilege to have Mr. Albert shadowing her for the last week and a half and staying until the bitter end.

*

40th Annual Norman Day Celebration. Mr. Steve Lewis, City Manager, provided photographs from the 40th Annual Norman Day Celebration. He said approximately 5,000 people were inside the park that evening. He said the rain was problematic but it turned out well.

*

Miscellaneous Discussion, continued:

Westwood Tennis Center. Mr. Steve Lewis, City Manager, provided photographs of the new youth tennis courts at the Westwood Tennis Center. He said they were the first of their kind in Oklahoma. He said this will provide opportunities to youth to learn the sport.

*

Westwood Golf Tournament Pavilion. Mr. Steve Lewis, City Manager, provided photographs of the new Westwood Golf Course tournament pavilion which is approximately 26 feet by 50 feet in size and this should be completed by the end of August, 2015.

*

Norman Junior Police Academy. Mr. Steve Lewis, City Manager, said 18 students between the 7th and 9th grade students had been in the Norman Junior Police Academy program this year. He said they learned about cyber safety, forensics, and bicycle and firearms safety. He said it was a great program.

*

Central Oklahoma Master Conservancy District (COMCD). Mr. Steve Lewis, City Manager, said the City had recently adopted the Strategic Water Supply Plan and one of the main emphases of the plan was to move toward water reuse. He said COMCD has been approaching this with a three-phase approach. He said Garver, L.L.C., has been engaged to look at some of the contaminants within Lake Thunderbird that have contributed to its impaired status, specifically phosphorous and turbidity. He said COMCD asked Garver to meet with the Oklahoma Department of Environmental Quality (ODEQ) to get their feedback in that process. He said COMCD voted to move forward with the second step which was to look at nitrogen and total dissolved solids within the lake. He said Phase 3 which is still years out and not budgeted, would be looking at the feasibility of reuse in Lake Thunderbird. He said before the reuse strategy is fully implemented, the City will have to complete all three phases. He said staff hears a lot about citizens' interest in looking at the impact of pharmaceuticals, etc., in the lake and staff and the COMCD Board are both very interested in that. He said one of the drivers for this issue has been trying to find an additional water supply for this community.

*

United Way. Mayor Rosenthal said today the United Way kicked off their campaign with their Pacesetter efforts and she made a commitment to the new Executive Director to help be one of the City's champions for United Way and challenged all Councilmembers to be part of the City's Pacesetter Campaign and can even donate from their paycheck which won't get them very far but will still be helpful.
