THENCE South 89°36'51" West, parallel with the north line of said Northwest Quarter, a distance of 670.14 feet to a point on the west line of said Northwest Quarter;

THENCE North 00°19'40" West, along the west line of said Northwest Quarter, a distance of 613.00 feet to the point of beginning.
