

TEMPORARY CONSTRUCTION EASEMENT

Know all men by these presents:
The limb of LLC
That Imhoff LLC, of Cleveland County, State of Oklahoma, for and in consideration of the sum of One Dollar (\$1.00) and other good and, valuable consideration, has/have this day sold to the City of Norman, a temporary easement over the following described land to wit:
A tract of land being a part of Lot 1, Block 1, Crossroads Boulevard Addition, City of Norman, Cleveland County, Oklahoma, filed at Book of Plats 11, Page 169 in the records of Cleveland County Clerk, being more particularly described as follows:
BEGINNING at the most easterly Southeast corner of said Lot I (P.O.B1.1); THENCE along a non-tangent curve to the left, being the south line of said Lot I, with a radius of 140.00', having a chord that bears S 38°58'06" W a distance of 66.05 feet, for an arc distance of 66.68 feet to the most southerly Southeast corner of said Lot I;
THENCE S 68°32'19" W, along the south line of said Lot 1, a distance of 5.10 feet; THENCE N 16°18'06" E a distance of 23.38 feet; THENCE N 43°12'28" E a distance of 36.16 feet;
THENCE N 63°15'13" E a distance of 16.72 feet to a point on the easterly line of said Lot 1; THENCE S 00°34'43" E, along the east line of said Lot 1, a distance of 3.11 feet to the POINT OF BEGINNING.
Said tract of land containing 0.010 Acres (439 Sq. Ft.).
All bearings contained in this description are based on the Oklahoma State Plane Coordinate System and are not astronomical bearings.
With the right of ingress and egress to and from the same, for the purpose of surveying, laying out, constructing, maintaining, and operating a public roadway, drainage structure or utility.
The sole purpose of this easement is to grant to the City of Norman the right to work on the above-described tract of land, and includes the right to use and remove any and all sand, rock, dirt, gravel, and other road building materials from the above-described tract of land.
It is a condition of this easement that it shall not be filed for record and that all rights conveyed to the City of Norman by this instrument shall terminate upon completion of construction of the project.
